**FIRST AMENDMENT TO PROFESSIONAL ENGINEERING SERVICES  
AGREEMENT  
C-21-0947-05-17**

This **FIRST AMENDMENT** to the Professional Engineering Services Agreement C-21-0947-05-17 (“Agreement”) by and between **The County of Hidalgo, Texas** (“County”) and **INTERA, Inc.** (“Consultant/Engineer”) (collectively “Parties”) is made this 21 day of March 2023, between the Parties, as follows:

**WHEREAS**, on or about May 17, 2022, the County entered into an Agreement with Consultant/Engineer to provide Air Curtain Incinerator Permitting Assistance for Precinct 3 (the “Services”) to the County following a request by Precinct 3 Commissioner, an elected office of the County, as described in the Service Contract;

**WHEREAS**, the Contract will expire on May 16, 2023;

**WHEREAS**, it has become necessary to incorporate additional services as part of the Services and as such to also extend the term of the agreement under the same rates, terms and conditions;

**WHEREAS**, the Contract provides that it may be modified or amended only by agreement in writing executed by the parties hereto, and not otherwise, pursuant to the Agreement;

**WHEREAS**, the Parties desire to amend the Agreement as hereinafter provided.

**NOW THEREFORE**, for and in consideration of the terms and provisions of this First Amendment to Professional Engineering Services Agreement and other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, County and Consultant/Engineer hereby agree:

1. Revise No. 7 of the Agreement to read:

**7. Term.** The term of this Contract is for two (2) years and will be effective upon approval of award and end May 16th, 2023. The term of this agreement may be extended at the County’s sole discretion for two (2) additional one (1) year term(s) under the same rates, terms and conditions. County will reserve the right to continue this Contract for an additional sixty (60) day Grace Period at the end of any term under the same rates, terms, and conditions. The Consultant/Engineer will not begin to work or incur costs until authorized in writing by the County for each “Purchase Order”.

2. County hereby agrees to exercise the first of its two (2) additional one (1) year options to

extend the term of the Agreement commencing at the conclusion of the initial contract term (May 16, 2023).

- 3. Parties agree to incorporate the additional services and corresponding cost estimate dated February 17, 2023, attached herein as Exhibit A to supplement the same incorporated into the Agreement as Attachments B & C respectively.
- 4. Except as modified herein, all terms and conditions of the Agreement, as amended, remain in full force and effect and Consultant/Engineer and County ratify and confirm the terms and provisions of the Agreement as amended.

**RE: Precinct 3 – Proposal for Air Curtain Incinerator Permitting Assistance**

Dear Commissioner Villarreal

INTERA Incorporated (INTERA), who acquired Cook-Joyce in 2021, hereby presents this proposal for the completion of air quality permitting of an Air Curtain Incinerator (ACI). The scope consists of two tasks, one being for INTERA to complete the submittal of a permit application to the Texas Commission on Environmental Quality (TCEQ) and to provide Public Notice support and liaison with the TCEQ. The basis for the proposal is provided below.

**SCOPE OF WORK**

**Task 1 – Finalize Permit Application, Submit to TCEQ, and Remit Permit Application Fee**

INTERA incorporates comments from the review of the draft permit application and prepares the submittal for electronic delivery to the TCEQ via their State of Texas Electronic Environmental Reporting System (STEERS). The permit application is compiled in Adobe PDF format and is uploaded to STEERS in their respective sections per TCEQ requirements. INTERA remits the permit fee on behalf of Hidalgo County, which is \$900 since the capital costs associated with this ACI project are less than \$300,000.

**Task 2 – Post-Submittal and Public Notice Support**

INTERA works with the permit reviewer at the agency during the review process of the application. INTERA responds to questions and Notices of Deficiency (NOD) that are sent by the permit reviewer and amends items as necessary per the agency's request. Negotiations of the final permit conditions are also handled by INTERA on behalf of the County in order to facilitate the issuance of a complete, accurate, and functional permit for the site.

INTERA also provides support with regard to Public Notice requirements, namely by coordinating publication in the local English and Spanish-language newspapers, working with the County to create appropriate signage, and preparation and submittal of a hardcopy of the application to the local public library for review and inspection by the general public. The County is responsible for remittance of payment of fees associated with newspaper publication and signage.

**ESTIMATED COST**

INTERA estimates that the project will require \$18,000 USD in funding, on a time and materials basis, to accomplish the tasks outlined above.
