**FIRST AMENDMENT TO LIMITED SERVICE DEPUTY AGREEMENT  
BETWEEN COUNTY OF HIDALGO AND LONE STAR NATIONAL BANK**

This **FIRST AMENDMENT** to the Limited Service Deputy Agreement (“Agreement”) is made this 23<sup>rd</sup> day of March 2023, by and between **The County of Hidalgo, Texas**, by and through its **Hidalgo County Tax Assessor-Collector** (hereinafter referred to as “**County**”) and **Lone Star National Bank** (hereinafter referred to as “**Deputy**”) (collectively “**Parties**”), as follows:

**WHEREAS**, on or about June 16, 2020, the County entered into a Limited Service Deputy Agreement with Deputy to be deputized to perform motor vehicle registration services as a limited service deputy in accordance with §520.0071 of the Texas Transportation Code and Subchapter H of Chapter 217 of the Texas Administration Code;

**WHEREAS**, Deputy provided as part of that Agreement a list of six (6) locations wherein it would provide limited service deputy services;

**WHEREAS**, Deputy paid the required bond for each of the six (6) locations as provided in section 2 of the Agreement;

**WHEREAS**, Deputy desires to add three (3) additional physical locations within Hidalgo County to provide limited deputy services in accordance with the Agreement and desires to pay the required bond for each additional location in accordance with section 2 of the Agreement;

**WHEREAS**, the Contract provides that it may be modified or amended only by agreement in writing executed by the parties hereto, and not otherwise, pursuant to the Agreement;

**WHEREAS**, the Parties desire to amend the Agreement as hereinafter provided.

**NOW THEREFORE**, for and in consideration of the terms and provisions of this First Amendment to the Limited Service Deputy Agreement and other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, County and Company hereby agree:

1. Exhibit A attached to the Limited Service Deputy Agreement listing locations wherein Deputy provides limited service deputy services is hereby replaced by the updated Exhibit A attached to this Amendment referencing additional locations wherein Deputy will provide limited service deputy services.
2. Deputy agrees to pay the bond amounts for the additional limited service deputy locations

as provided by section 2 of the Agreement.

- 3. Except as modified herein, all terms and conditions of the Agreement, as amended, remain in full force and effect and Deputy and County ratify and confirm the terms and provisions of the Agreement as amended.






