**FIRST AMENDMENT TO CONSTRUCTION CONTRACT  
C-21-0832-02-11**

This **FIRST AMENDMENT** to the **Construction Contract** is made on this the 04 day of April, 2023, by and between the **County of Hidalgo, Texas** (the “County”) and **RG Enterprises, LLC dba G & G Contractors** (“**CONTRACTOR**”)

**WHEREAS**, on or about the February 11, 2022, County and Contractor entered into a Construction Contract for “Construction of Hidalgo County Precinct No. 4 All-Star Park” (herein after referred to as the “Initial Agreement”);

**WHEREAS**, the Initial Agreement provides that ten (10) percent of estimated payment amounts shall be retained by the County until final completion and acceptance of all work covered by the Initial Agreement;

**WHEREAS**, the parties desire to amend the Initial Agreement to clarify and correct the retainage percentage amount as herein provided.

**NOW THEREFORE**, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Contractor hereby agree that said Agreement is amended as follows:

**Retained Percentage:**

1. The retainage percentage provided in the Initial Agreement is amended by providing that five (5) percent of the estimated amounts shall be retained until the final completion and acceptance of all Work covered by the Contract.
2. The amended retainage percentage is effective as of the date the parties entered into the Initial Agreement.

Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect. County and Contractor ratify and confirm the terms and provisions of the Construction Contract as amended herein.
