**4th AMENDMENT TO SERVICE CONTRACT
C-15-098-06-02**

This **AMENDMENT** to the service contract for “**Housing and Confinement of Inmates**” for **Hidalgo County** in connection to original contract **C-15-098-06-02**, dated June 17, 2015, by and between **HIDALGO COUNTY, TEXAS** (“County”) and **The GEO Group, Inc.** (“Company”) is entered into between the parties effective this **17th** day of **June 2023**.

WHEREAS, Company and County entered into a Contract dated **June 17, 2015**, in which Company agreed to provide certain services for the purpose of “**Housing and Confinement of Inmates**” for **Hidalgo County** (the “Contract”);

WHEREAS, Section 6.05 titled Amendment allows for C-15-098-06-02 to be modified or amended “by a written instrument executed by the duly authorized representatives of both parties and approved by Commissioners Court of the County”;

WHEREAS, on the 2nd day of June 2020, the parties amended Section 4.03 titled Per Diem Rate of C-15-098-06-02 “to increase the per diem rate of actual housing and care of County inmates, and related detention and transportation services,” to reflect “Fifty-Nine Dollars (\$59.00) per inmate, per day” and further extended C-15-098-06-02 to June 16, 2021;

WHEREAS, on the 17th day of June 2021, the parties amended Section 4.03 titled Per Diem Rate of C-15-098-06-02 “to increase the per diem rate of actual housing and care of County inmates, and related detention and transportation services,” to reflect “sixty dollars and eighteen cents (\$60.18) per inmate, per day” and further extended C-15-098-06-02 to June 16, 2022;

WHEREAS, on the 17th day of June 2022, the parties amended Section 4.03 titled Per Diem Rate of C-15-098-06-02 “to increase the per diem rate of actual housing and care of County inmates, and related detention and transportation services,” to reflect “sixty one dollars and ninety-nine cents (\$61.99) per inmate, per day” and further extended C-15-098-06-02 to June 16, 2023;

WHEREAS, the County also wishes to exercise its option for annual renewal of the contract and;

WHEREAS, the parties desire to amend the Contract to increase the per diem rate of actual housing and care of County inmates.

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Company hereby agree to the following amendment to the Contract:

1. The following section 4.03 shall be amended to the Contract under the heading “Per Diem Rate”;

Sixty-Three Dollars and Eighty-Five Cents (\$63.85) per inmate, per day.

2. Additionally, as per the agreement and at its sole discretion, the County hereby renews this contract for an additional one (1) year term beginning June 17, 2023 and expiring June 16, 2024

Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect and Company and County ratify and confirm the terms, and provisions of the Contract as amended.
