Proclamation Honoring the Service of Mrs. Mari Gutierrez upon her Retirement from Hidalgo County

Whereas Mrs. Mari Gutierrez has been an employee of Hidalgo County for 30 years, where she has gladly undertaken different roles and responsibilities; and

Whereas Mari began her employment with the County of Hidalgo in 1992 at the District Clerk's office under Mrs. Pauline Gonzalez. Mari then transitioned to the County Judge's office from late 1992 through 2001 where she was promoted from Clerk to Executive Assistant to former County Judge J. Edgar Ruiz; and

Whereas during her tenure at the County Judge's Office, Mari also worked for former County Judge Richard Garcia and former County Judge Renato Cuellar; and

Whereas Mari then transitioned into the role of Assistant Court Coordinator for Precinct 1's Justice of the Peace Jesus "Jesse" Morales from 2001 to 2003; and

Whereas Mari later joined the County Clerk's office from 2003 to 2005 working as an Executive Assistant to J.D. Salinas, III and stayed working alongside him as he moved up from County Clerk to County Judge from 2006 to 2010. Her responsibilities grew vastly as she also assisted the Hidalgo County Emergency management team during emergencies while organizing conferences and helping review legislative issues; and

Whereas Mari also briefly worked alongside interim County Judge Rene Ramirez and then went on to re-join the Hidalgo County Precinct 1 family in 2010 as Administrative Assistant to former Commissioner AC Cuellar, Jr., former Commissioner Joel Quintanilla, and current Commissioner David L. Fuentes; and

Whereas Mari has been an integral part of the Precinct 1 team and the Hidalgo County organization for 30 years.

Now therefore, be it proclaimed that the Hidalgo County Commissioners Court hereby offers its deepest gratitude and congratulations to Mrs. Mari Gutierrez on behalf of the people of Hidalgo County and wishes her well in this next chapter of her life upon retirement.
