  - a. Community Park Playground was destroyed by arson. City and Insurance company are working to determine payment for the structure. The portion of the playground that survived the fire without damage has been moved to the Community Center.
  - b. Saturday is the soft opening at the Skate Park from 1:30 pm to 3:30 pm. Dayton Children's Hospital will be providing 60 skate helmets for the event.
  - c. Survey results for Dial Park have been returned from the data collection company. 472 residents responded to the survey. Final report will be finished in December and those results will be shared with Council and the Park & Recreation Board.
  - d. Technology upgrades on-going at the Community Center.
