#### A. February 23, 2022

#### 5. Old Business

#### A. Community Health Clinic - June 20, 2022

Ms. Sumlin speaks about culture week, the same week as Juneteenth. She spoke with the community program coordinator at Premiere Health, who states that she might be able to collect 2 sources of funding. One of the sources of funding is community benefits where different community projects focus on community health. Another source of funding is a grant from the hospital foundation used to help with community events where the focus is on health and community engagement.

Ms. Sumlin states that a meeting with both Samiya (spelling?) and her program director will be scheduled for some time next week. There's availability on the 20th between 10am-3pm, which would be the time for premiere to set up. Perhaps another group might be able to come in between 3pm-7pm to do chair massages for the community. The idea is posed that this should be made overall a community health day.

On June 25th, a hopeful exhibitor booth (no sales) to show people what services are available. Ms. Sumlin stated that Premiere can do all three events if they are the only providers at the event all day. Vaccines, A1C sticks, and other standard preventative type things at a doctor's office.

Ms. Purvis asks what the target audience for the community health clinic is and how will we advertise to get the people to the event. Ms. Sumlin says that it's not just for this event, but for the cultural festival. This advertising isn't something that this board can do by themselves, council help will be needed. Ms. Sumlin proposes that advertising should be done in Hilltop and other apartment complexes and other areas of the community where people are experiencing some inequity. Information can be placed at the senior center.

Vendors will be at the event to sale items for profit. Needs a meaningful name.

Ms. Purvis said it's a struggle because it's not a protected group (?). This was said to have not been added to the legislation. Ms. Collins-Stephens says everything still must be from an intersectional lens.

Ms. Purvis suggests reaching out to one of the LGBTQ+ organizations in Dayton to set up a booth. Ms. Collins-Stephens suggests that her issue is that we focus on the issue at hand. Ms. Sumlin suggests that we focus on the minorities that are already discriminated against. Statistics, community resources and more information will be gathered before moving forward.
