A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA HABRA APPOINTING JERRY L. PRICE FOR POSITION OF INTERIM POLICE CHIEF UNDER GOVERNMENT CODE SECTION 21221(h)

WHEREAS, Jerry L. Price will retire from the position of Police Chief for the City of La Habra, effective December 18, 2020.

WHEREAS, Jerry L. Price has specialized skills and knowledge required for the continued successful operation of the public business of the City of La Habra.

WHEREAS, the City of La Habra is in the process of actively recruiting a qualified permanent replacement for Jerry L. Price as Police Chief;

WHEREAS, the City of La Habra would like to retain Jerry L. Price's services as Interim Police Chief to allow the City of La Habra sufficient time to obtain a qualified replacement;

WHEREAS, Jerry L. Price possesses necessary and specialized skills to perform the functions of Police Chief during recruitment, and to prevent stoppage of that vital public service;

WHEREAS, the City Council of the City of La Habra hereby appoints Jerry L. Price to the position of Interim Police Chief under Government Code section 21221(h), an appointment deemed to be for interim purposes and requiring specialized skills, effective December 28, 2020, and for a period not to exceed twelve (12) months or when the City hires a permanent replacement, whichever is earlier, and subject to a limit of 960 hours for all CalPERS employers in a fiscal year.

WHEREAS, the appointment of Jerry L. Price as Interim Police Chief under Government Code section 21221(h) shall only be made once.

WHEREAS, the compensation of Jerry L. Price shall not be less than the minimum nor exceed the maximum monthly pay rate on the City's publicly available pay schedule for the vacant position of Police Chief, divided by 173.333 to equal an hourly rate. Jerry L. Price shall not receive any benefits, incentives, or compensation in addition to the hourly rate.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of La Habra that Jerry L. Price is appointed Interim Police Chief, effective December 28, 2020, based on the terms described in the "Retired Annuitant Employment Agreement" attached to this Resolution.
