2. APPROVE TO AMEND THE BUDGET FOR THE COMMUNITY SERVICES DEPARTMENT, EMPLOYMENT AND TRAINING DIVISION, AND ADD AN EMPLOYMENT AND TRAINING PROGRAM COORDINATOR POSITION

That the City Council approve a budget amendment for the Community Services Department, Employment and Training Division, and add an Employment and Training Program Coordinator position.

CONSIDERATION ITEMS:

1. CONSIDER REINSTATEMENT OF LA HABRA MUNICIPAL CODE 10.20.180

Police Captain Foster presented the staff report. He noted that staff is aware of the recent regression in Orange County as it relates to the State of California COVID-19 parameters; however do not anticipate another lockdown in the community.

City Council discussion included: potential postponement of City Council action; confirmation of the reinstatement of and potential reversal of this proposed action should state mandated orders change; cost of water bill inserts; verification that although legally the city does not have to notify residents, they are notified; the process for issuing warnings to residents.

City Manager Sadro indicated the reinstatement would not become effective until January 2021, so it could be monitored potential state mandated stay-at-home orders. He reviewed the emergency provisions that he had under the Declaration of Emergency in regards to this item. He stated that delaying the reinstatement could cause unnecessary late water bill notification inserts to residents.

Mayor Beamish invited the public to testify at 6:45 p.m. There was no public testimony.
