A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA HABRA APPROVING THE PURCHASE OF 222 SOUTH EUCLID STREET FROM VISHNU A. PATEL AND RITA V. PATEL, TRUSTEES, UNDER THE PATEL FAMILY TRUST DATED MAY 31, 2007,

WHEREAS the City of La Habra (City) desires to purchase and VISHNU A. PATEL AND RITA V. PATEL, TRUSTEES, UNDER THE PATEL FAMILY TRUST DATED MAY 31, 2007 (Seller) agrees to sell the real property consisting of approximately 4,275 square feet of land, generally located at 222 South Euclid Street (Property), in the City of La Habra; and

WHEREAS, pursuant to Health and Safety Code Section 34315, the City has the power to purchase real property; and

WHEREAS, the Seller agrees to sell the Property to the City at the fair market value purchase price of Two Hundred-five Thousand (\$205,000), and to transfer the property by grant deed.

NOW, THEREFORE, THE LA HABRA HOUSING AUTHORITY DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. Recitals. The Recitals set forth above are true and correct and are incorporated into this Resolution by this reference.

Section 2. CEQA Compliance. The La Habra Housing Authority hereby finds and determines that it can be seen with certainty that there is no possibility that selling the Property will have a significant adverse effect on the environment. Thus, the adoption of this Resolution is exempt from the requirements of the California Environmental Quality Act (CEQA) pursuant to Section 15061(b)(3) of the CEQA Guidelines. Staff is directed to file a Notice of Exemption with Orange County Clerk's Office within five (5) working days of adoption of this Resolution.

Section 3. General Plan Conformity. As required by Government Code Section 65402, the Planning Commission considered the proposed sale and determined that the proposed sale was in conformity with the City's General Plan on December 14, 2020.

Section 4. Approval of Purchase of Property. The City hereby approves the purchase of the property from the Seller, and authorizes and directs the City Manager to sign a certificate of acceptance of the Grant Deed and perform all obligations of the City necessary to transfer the Property from the Seller to the City.

Section 5. Severability. If any provision of this Resolution or the application of any such provision to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Resolution that can be given effect

without the invalid provision or application and, to this end, the provisions of this Resolution are servable. The City Council declares that the City Council would have adopted this Resolution irrespective of the invalidity of any particular portion of this Resolution.

Section 6. Certification. The City Clerk of the City of La Habra shall certify the adoption of this Resolution.

Section 7. Effective Date. This Resolution shall become effective immediately upon adoption.
