

ORDINANCE NO. 1317

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LA HABRA
ADDING TO THE LA HABRA MUNICIPAL CODE, AS CHAPTER 9.22,
THE UNIFORM FIRE CODE SECTION PROHIBITING ANY FIREWORKS

WHEREAS, on April 21, 1959, the City of La Habra adopted the Fire
Prevention Code Section prohibiting fireworks of any kind; and

WHEREAS, the City of La Habra also adopted the 1961, 1967, 1973,
1979 and 1985 Editions of the Uniform Fire Code, including the section
prohibiting fireworks; and

WHEREAS, the City Council is desirous of adding to the Municipal
Code the Uniform Fire Code section prohibiting fireworks,

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LA HABRA DOES ORDAIN
AS FOLLOWS:

That a new Chapter is hereby added to the La Habra Municipal Code,
as follows:

9.22 Fireworks
9.22.010 Fireworks Prohibited

It shall be unlawful for any person to possess, store, to offer
for sale, expose for sale, sell at retail or use or explode any
fireworks, provided that the chief shall have power to adopt
reasonable rules and regulations for the granting of permits
for supervised public displays of fireworks by a jurisdiction,
fair associations, amusement parks, other organizations or for
the use of fireworks by artisans in pursuit of their trade.
Every such use or display shall be handled by a competent
operator approved by the chief and shall be of such character
and so located, discharged or fired so as, in the opinion of
the chief after proper investigation, not to be hazardous to
property or endanger any person.
