A RESOLUTION OF THE CITY OF LA HABRA APPOINTING DAVID CRABTREE AS INTERIM DIRECTOR OF COMMUNITY AND ECONOMIC DEVELOPMENT UNDER GOVERNMENT CODE SECTIONS 7522.53 & 21221(h)

**WHEREAS**, in compliance with Government Code Sections 7522.56 and 21221, the City Council of the City of La Habra must provide CalPERS this certification resolution when hiring a retired annuitant to an interim position; and

**WHEREAS**, David Crabtree, CalPERS ID # 339682579, retired from the City of Brea in the position of Director of Community Development, effective December 28, 2019; and

**WHEREAS**, David Crabtree has specialized skills and knowledge required for the continued successful operation of the public business of the City of La Habra; and

**WHEREAS**, the City of La Habra is in the process of actively recruiting a qualified permanent replacement for David Crabtree as Director of Community and Economic Development; and

**WHEREAS**, the City of La Habra would like to retain David Crabtree's services as Interim Director of Community and Economic Development to allow the City of La Habra sufficient time to obtain a qualified replacement; and

**WHEREAS**, David Crabtree possesses necessary and specialized skills to perform the functions of Director of Community and Economic Development during recruitment, and to prevent stoppage of that vital public service; and

**WHEREAS**, the City Council of the City of La Habra hereby appoints David Crabtree to the position of Interim Director of Community and Economic Development under Government Code section 21221(h), an appointment deemed to be for interim purposes and requiring specialized skills, effective July 6, 2021 and for a period not to exceed twelve (12) months or when the City hires a permanent replacement, whichever is earlier, and subject to a limit of 960 hours for all CalPERS employers in a fiscal year; and

**WHEREAS**, the appointment of David Crabtree as Interim Director of Community and Economic Development under Government Code section 21221(h) shall only be made once; and

**WHEREAS**, the compensation of David Crabtree shall not be less than the minimum nor exceed the maximum monthly pay rate on the City's publicly available pay schedule for the vacant position of Director of Community and Economic Development, divided by 173.333 to equal an hourly rate. David Crabtree shall not receive any benefits, incentives, or compensation in addition to the hourly rate; and

**WHEREAS**, the hourly rate paid to David Crabtree will be \$89.50 and will not receive any other benefit, incentive, compensation in lieu of benefit or other form of compensation in addition to this hourly pay rate; and

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of La Habra does hereby resolve the appointment of David Crabtree as Interim Director of Community and Economic Development, effective July 6, 2021, based on the terms described in the "Retired Annuitant Employment Agreement" attached to this Resolution.
