Dear La Habra City Council:

Once again it has been brought to our attention that there is a proposed adjustment being considered to our water and sewer rates. Over the years, we have lived here 37 years, we have seen these raises as well as being asked to conserve water. We have gone along with it but now feel we need to speak up. La Habra has a large population of retired people as well as low-income families (who in many cases can get assistance with their bills) and a raise in our basic utilities is asking too much. Many have left their lawns go to pot to help with the water problem because they can't afford to plant or relandscape their yards. Our income is FIXED....if you ask for a hike and the electric company asks for a hike and our food and gas prices keep going up we are beginning or have started to struggle financially. Many of our friends have moved away and many are also thinking of downsizing as they can't keep up with everyone asking for a price increase. There needs to be a STOP to this and for other solutions to be brought to the table. We have many apartments and condos in our city who use far more water in their units than a normal household and their landscaping is plush because they don't have to worry about their usage. It's paid by their associations. The associations don't restrict them of their usage. A single condo or apt. feel no pain or restriction from their water usage. Single family residences do and are asked to pay a monthly bill. Depending on their circumstances they try to reduce their usage so they can pay their bills.

I truly hope you will consider finding another method instead of increasing our monthly payments in a year of so many increases and trying to recover from the COVID disaster.

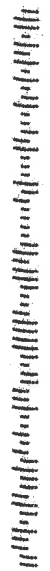

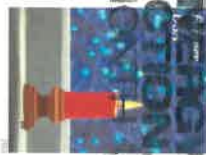
