A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA HABRA, ORANGE COUNTY, CALIFORNIA, TEMPORARILY REDUCING SOLID WASTE SANITATION FEES AND SOLID WASTE FRANCHISE FEES

WHEREAS, the City of La Habra receives solid waste franchise fees and solid waste sanitation fees; and

WHEREAS, the City Council desires to temporarily reduce the rates of these fees; and

WHEREAS, the City Council finds that such temporary reduction is in the public interest because of the recent historic levels of inflation and the need for rate relief at this time; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LA HABRA HEREBY RESOLVES AS FOLLOWS:

SECTION 1: The City Council finds that all the facts, findings, and conclusions set forth above in this Resolution are true and correct.

SECTION 2: The rate of the Residential Franchise Fee for Solid Waste Hauling Services is temporarily reduced from the existing 9.5% to 9.0%.

SECTION 3: The rate of the Commercial Franchise Fee for Solid Waste Hauling Services is temporarily reduced from the existing 11.5% to 11.0%.

SECTION 4: The rate of the Residential Sanitation Fee is temporarily reduced from the existing 22.3% to 18.0%.

SECTION 5: The Commercial Sanitation Fee will not be changed and will remain at the existing rate of 12.5%.

SECTION 6. The temporarily reduced rates set forth in Sections 2 through 4 of this resolution shall become effective July 1, 2022.

SECTION 7. The temporary reductions shall end on July 1, 2023. Effective on that date, the fees shall resume the rates, previously approved or consented to by the City Council that would have been effective in the absence of the temporary rate reductions.

SECTION 8. The intent of the City Council is that, on the date set forth in Section 7 of this Resolution, the existing rates of the fees will be restored without any additional action of the City Council beyond the adoption of this Resolution. The City Council would not have adopted this Resolution if such restoration of the existing rates required additional action of the City Council or was subject to any protest right or necessity of obtaining the consent of any person.

SECTION 9. This resolution shall become effective immediately upon its adoption.
