#### A. COMMUNITY SERVICES COMMISSION REORGANIZATION

Commission Laveaga nominated Commissioner Rojas as the Vice Chair but there was not a second. There was discussion that Commissioner Rojas will provide support to Vice Chair Garcia should there be a conflict with her schedule.

The following Commissioners read the Oath of Office as their reappointment to the Community Services Commission: Chair Kempker, Vice Chair Garcia & Commissioner Rojas

#### B. COMMUNITY ENGAGEMENT DISCUSSION TO HELP REVITALIZE THE LA HABRA DOWNTOWN DISTRICT

Commissioner Rojas gave a presentation on an idea about how the Community Services Commission may better serve the community. In preparation for his interview with the city council, he researched the City's Goals & Objectives for 2022-2023. Goal #5 Objective H is to retain a consultant to help gather documents to establish a La Habra corridor or downtown district. Commissioner Rojas introduced the Love My City concept that was created by author Peter Kageyana. He helps cities create a sense of community and identify "what they love" about their city. Commissioner Rojas shared his experience in the City of Goleta where he was chair of the Parks & Recreation's first Commission.

Further commission discussion identified the following questions and issues:

1. What role does the Commission want to have with the La Habra corridor/downtown project?
2. Should we have a discussion with the City Council?
3. What do developers and the community want in La Habra?
4. Can we conduct community surveys? What do they love about La Habra?
5. Does the Commission want to help facilitate a one-day workshop to start a conversation about what residents love about and want in La Habra? (15 – 150 community members)
6. How do we present this idea to the City Council and Planning Commission?
7. Create a walkable City to reduce traffic.
8. Affordable housing La Habra because the location is in-between Orange County and Los Angeles County.

Director Fujio suggested that the Commission start by hosting an outreach meeting to get community input before approaching City Council.

Vice Chair Garcia suggested that residents provide feedback via surveys this summer at community events and at Love La Habra.

Commissioner Rojas would like to request that the City entertain the idea of hosting a workshop presented by Peter Kageyana. The workshop is not a contract. They will help collect important data to provide information to make future decisions.

Commissioner Laveaga asked if there was a current plan in place that could be shared with the Commission.

Director Fujio recommended that the Commission discuss next steps and bring back recommendations to the May meeting. The Commission needs to make sure the process does not interfere with the purview of the Planning Commission.

## **STAFF COMMENTS**

Director Fujio informed the Commission that the Children's Museum lawsuit trial ended and was in favor of the City.

She informed the Commission that a Park reservation policy is being drafted by staff to be implemented this summer. This will help ensure a fair and safe environment at City parks. The policy will be presented at the May meeting.

The Orange County Head Start program will not be renewed next year. The program will finish this year and end on June 30<sup>th</sup>. The City can re-apply in the future.

Community Services will provide Summer Enrichment programs for La Habra City School and Lowell Joint school districts. This program will operate from June – July.

Community Services hired a new Community Outreach Homeless Liaison that will start on May 9<sup>th</sup>. There are 45 identified homeless in La Habra.

There are currently part time recruitments for recreation leaders and case managers.

La Habra Meals on Wheels has relocated to the Hillcrest Health & Wellness Site.

Please stop by the Eggstravaganza Family Fair on Saturday, April 16<sup>th</sup>.
