- ❖ Commissioner Schmidt would like additional trashcans available for park rentals.
- ❖ Kelly Fujio, Director of Community Services said this summer will be a pilot program before fees are implemented next year. This is a first draft for consideration and to help with multiple groups wanting to use the same park. The policy will be enforced for use by reservation only.
- ❖ Vice Chair Garcia said the rental rates are all the same and that parks have different amenities. City staff will review.

III. CONSIDERATON ITEMS

1. That the Community Services Commission continue discussing ideas and strategies to engage the community in the “Love My City” concept.

Commissioner Rojas gave an update.

- ❖ He spoke with the author/facilitator Peter Kageyama.
- ❖ The workshop offered identifies key community assets including the emotionally engaged citizens that shape the city and develops strategies and tactics to engage these local development resources. The workshop focuses on locally based solutions that do not require significant resources and can be quickly implemented.
- ❖ Workshop elements include:
 - Overview of Lovable Cities
 - Wall of Love
 - Messages and marks – designing the City’s t-shirt
 - Love Notes – small things that have outsized impacts on the way people feel about their place.
 - Identify local rituals and traditions
 - Brainstorming \$500-dollar project
 - Voting and ranking of the best ideas for next steps
- ❖ Who should attend?
 - Elected Officials
 - Planning and City Manager
 - Municipal Employees and Department Leaders
 - Arts and Culture Leaders
 - Entrepreneurs and Business Leaders
 - Not for Profit Leaders
 - Young Leaders
 - Young Professionals
 - Student Leaders
 - Neighborhood Associations
 - Concern Citizens
- ❖ Attendance (up to 150)
- ❖ Venue (any location in the City for working tables for groups of 6 – 8)

- ❖ Consultant Fee: \$2,000 Pre-Workshop Consultation
- ❖ For “Love of La Habra” Community Workshop Session – 4 hour facilitated meeting \$5,000 Fee
- ❖ Travel from Clearwater, FL to Orange County, CA and return.

Vice Chair Garcia suggested that this concept be incorporated into the City’s Centennial Celebration in 2025.

Kelly Fujio, Director of Community Services cautioned the Commission to make sure this project stays in its purview. A recommendation is to consult with the City Manager before approaching the City Council and Planning Commission.

Commission Schmidt visited the Love My Cities website. She supports a consultant helping to facilitate this process.

Commissioner Rojas gave an update on the La Habra Outdoors Program. The registration packet is available and is in English and Spanish. He presented the program to the La Habra Host Lions Club and Rotary Club and they have committed to a financial donation. He is working with Aspi Packing Outfitters for a back-pack sponsorship and

Latina Outdoors for a t-shirt sponsorship for the beach day trip. The La Habra Collaborative will also provide toiletries and food for this program.

Commissioner Schmidt attended the grand opening at Pearl Vision.
