City Clerk Swindell administered the Oath of Office to newly elected Councilmember Espinoza, Councilmember Shaw, and Councilmember Simonian. Immediately following, City Clerk Swindell presented them with Certificates of Election as required by State Law. Councilmember Simonian took his seat at the dais.

Councilmember Espinoza recognized the recipients of the City of La Habra 2020 Holiday Home Decorating "Light Up the Season" Awards.

PUBLIC COMMENTS:

Chuck Krolkowski, Attorney with Newmeyer & Dillion, LLP representing the Kwon Family, owners of the Westridge Golf Course property, spoke regarding the unconstitutionality of Measure X - City of La Habra, City of La Habra Citizens' Initiative for the Preservation of Open Space in La Habra.

Christine Cook, La Habra resident, thanked Mayor Beamish and City Council for their service. Christine Cook suggested that City Council meetings be conducted via Zoom. She wished everyone a safe and healthy holiday and New Year.

Maribelle Lopez, La Habra resident, congratulated Councilmembers Espinoza and Shaw on their reelections, and Steve Simonian on his election to City Council. She encouraged safety during the COVID-19 pandemic and wished everyone Happy Holidays.

Councilmember Espinoza stated that Consideration Items would be discussed prior to the Consent Calendar items. She noted that Assistant City Attorney Collins would make an announcement for City Council consideration of an addition to Consideration Items.

Assistant City Attorney Collins stated that a provision to The Brown Act allowed City Council to add an item to the agenda after it had been posted if there was a finding for the need to take immediate action on an item, and the need came to the attention of City Council after the posting of the agenda.

Assistant City Attorney Collins spoke regarding the appeal for the release of several hundred prisoners from the Orange County jail facility, with the appeal expected to be filed. He indicated the City had an opportunity to join other cities and file an Amicus Brief to urge the court to take a different approach to this case. He confirmed that the item, if approved to be added, would be under the Consideration portion of the meeting.
