A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA HABRA, ORANGE COUNTY, CALIFORNIA, EXTENDING REDUCED RATES FOR SOLID WASTE SANITATION FEES AND SOLID WASTE FRANCHISE FEES

WHEREAS, the City of La Habra receives solid waste franchise fees and solid waste sanitation fees; and

WHEREAS, by its Resolution No. 6077, the City Council temporarily reduced the rates of these fees for fiscal year 2022-23; and

WHEREAS, the City Council desires to extend this rate reduction; and

WHEREAS, the City Council finds that this reduction is still in the public interest because of the historic levels of inflation and the need for rate relief; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LA HABRA HEREBY RESOLVES AS FOLLOWS:

SECTION 1: The City Council finds that all the facts, findings, and conclusions set forth above in this Resolution are true and correct.

SECTION 2: The rate of the Residential Franchise Fee for Solid Waste Hauling Services will continue to be reduced to 9.0% from the established rate of 9.5%.

SECTION 3: The rate of the Commercial Franchise Fee for Solid Waste Hauling Services will continue to be reduced to 11.0% from the established rate of 11.5%.

SECTION 4: The rate of the Residential Sanitation Fee will continue to be reduced to 18.0% from the established rate of 22.3%.

SECTION 5: The Commercial Sanitation Fee will not be changed and will remain at the established rate of 12.5%.

SECTION 6: The City Council's intent in adopting this resolution is to continue for an indefinite period the temporary rate reduction. Such reduction shall continue unless and until the City Council adopts a resolution restoring the full established rates. The City Council would not have adopted this Resolution if a restoration of the full rates were subject to any protest right or the necessity of obtaining the consent of any person.

SECTION 7: This resolution shall become effective immediately upon its adoption.
