SERVICE REQUIREMENTS

The minimum Child Days of Enrollment (CDE) Requirement shall be amended by deleting reference to 30,646.0 and inserting 39,287.0 in place thereof.

Minimum Days of Operation (MDO) Requirement shall be 246. (No Change)
