ADDITIONALLY, IT IS RECOMMENDED THAT THE CITY OF LA HABRA RETAIN FULL AND SOLE CONTROL OVER ALL ADVERTISING EFFORTS, DECISIONS, SOLICITATIONS, AND REVENUES IN ANY CITY PRODUCED OR SUPPORTED PUBLICATION, MAGAZINE, NEWSLETTER OR OTHER OUTREACH MATERIAL OR MEDIA, AND THAT ANY PROPOSAL TO SHARE ADVERTISING REVENUES WITH NON-CITY ENTITIES BE FIRST BROUGHT BEFORE THE CITY COUNCIL FOR REVIEW AND APPROVAL. Motion failed due to lack of second.

City Attorney/Legal Counsel stated a City Council motion to amend the proposed budget could be made by City Council. He further indicated broader direction by the City Council with respect to advertising revenues would have to be publicly agendaized as a separate non-budgetary item at a future City Council meeting. He clarified the motion is limited to budget considerations.

He apologized for cancellation of the first Movies in the Park due to inclement weather, and requested it be shown as the last movie of the series. He congratulated Councilmember/Director Medrano's daughters on their high school and college graduations.
