

RESOLUTION NO.

A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF LA HABRA FINDING THAT THE PROPOSED FISCAL YEAR 2023-2024 SEVEN-YEAR CAPITAL IMPROVEMENT PROGRAM IS CONSISTENT WITH THE GOALS AND POLICIES OF THE LA HABRA GENERAL PLAN 2035 PURSUANT TO GOVERNMENT CODE SECTIONS 65103, 65401 and 65403.

The Planning Commission of the City of La Habra does hereby resolve as follows:

Section 1. The Planning Commission does hereby find and determine that:

- a. The City of La Habra Public Works Department submitted the proposed Seven-Year Capital Improvement Program (7-Year CIP) to the Planning Commission for a determination of consistency with the La Habra General Plan 2035 per Sections 65103, 65401 and 65403 of the California Government Code.
- b. The 7-Year CIP was reviewed for conformance with the California Environmental Quality Act and the California Public Resource Code, Division 13. Since the 7-Year CIP is a public improvement and transportation planning document which identifies areas for possible improvements based on the availability of funding, the approval of the 7-Year CIP is exempt from the California Environmental Quality Act (CEQA) Section 21080, (b)(1). Should a specific improvement identified in the 7-Year CIP be undertaken, a full environmental analysis of that improvement will be performed in accordance with the requirements of CEQA.
- c. The proposal has been reviewed pursuant to the requirements of the City's National Pollutant Discharge Elimination System (NPDES) Municipal Permit, the Local Implementation Plan (LIP), and the Model Water Quality Management Plan (WQMP), Section 7.2. The 7-Year CIP is a planning document with identified improvements made as funding becomes available. Should a specific improvement be undertaken, a full review of its impacts to the Stormwater System shall be undertaken and will incorporate Best Management Practices (BMPs).
- d. The Planning Commission held a duly noticed public hearing on June 12, 2023 on the proposed 7-Year CIP for consistency with the La Habra General Plan 2035. The Planning Commission, after considering all the written and oral evidence offered including the staff report and all attachments, determines that the 7-Year CIP is consistent with General Plan 2035 pursuant to Government Code Section 65103, 65401 and 65403.

Section 2. The Planning Commission further finds and determines that the proposed 7-Year CIP is consistent with the following goals and policies of the La Habra General Plan 2035:
