1. Community Services Commission Meeting Minutes for January 11, 2023.

III. CONSIDERATION ITEMS

1. Proposed Park Name for 200 West Greenwood Avenue

Michael O'Toole, Assistant Planner made a presentation on naming the new park site. Through the proposition 68 Statewide Park Development Program, the City of La Habra obtained a grant for the development of a new neighborhood park at 200 West Greenwood Avenue. The new park site was formerly occupied by the clubhouse for the La Habra Woman's Club; however, the building has been demolished due to its dilapidated condition. Subsequent to the demolition of the building, the subject property was purchased by the City for development of a public park.

The proposed names include:

- Las Reinas Park
- Las Doñas Park
- Las Soñadores Park
- Las Damas Park
- Jardin de Las Damas

Natalie White, La Habra Woman's Club President spoke on behalf of the organization. The Club would like to stay involved and help with the maintenance of the new park. The names that the Woman's Club selected in order of preference:

1. Las Reinas Park (Queens Park)
2. Las Donas Park (The Ladies Park: Donas is a term for a woman that indicates seniority)

Commissioner Laveaga asked who is the first woman club president.

Vice Chair Commissioner indicated that the City's Centennial Celebration is in 2025 and there may be a way to tie the name into the new park name.

Natalie White, La Habra Woman's Club President said their Club is celebrating their 125th anniversary.

MOVED BY COMMISSIONER SCHMIDT, seconded by COMMISSIONER LAVEAGA and CARRIED 3-0, TO RECOMMEND THE NAMING OF NEW PARK AT 200 WEST GREENWOOD AVENUE BE NAMED LAS REINAS PARK AND LAS DONAS PARK AS AN ALTERNATIVE OPTION. Said motion CARRIED by the following roll call vote:
