

**RESOLUTION NO. CC 2024-\_\_**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA HABRA, ORANGE COUNTY, CALIFORNIA, AMENDING THE MASTER SCHEDULE OF FEES PERTAINING TO FEES FOR GENERAL SERVICES, ADMINISTRATIVE SERVICES, COMMUNITY DEVELOPMENT SERVICES, BUILDING SERVICES, FIRE SERVICES, POLICE SERVICES, AMBULANCE SERVICES, PUBLIC WORKS SERVICES, UTILITY SERVICES, AND PENALTIES FOR MUNICIPAL CODE AND VEHICLE CODE PARKING VIOLATIONS

**WHEREAS**, a cost allocation plan was developed in Fiscal Year 2015-16 to determine the actual cost of providing various services to the public and to assist with recommendations for adjustments to such fees; and

**WHEREAS**, the City Council passed Resolution No. 5374 on April 4, 2016, amending the Master Schedule of Fees to be based upon this cost allocation plan; and

**WHEREAS**, the City may periodically adjust fees for services as allowed by state law and as necessary to recover up to the full amount of the cost of providing service and to account for any increase or decrease in the cost of living per Section 4.08.010 of the La Habra Municipal Code; and

**WHEREAS**, the Consumer Price Index for the Los Angeles–Long Beach–Anaheim is regarded as an appropriate index upon which to base fee adjustments, and the City Council wishes to increase the fee rates contained in the Master Schedule of Fees by 3.48 percent, the actual annual change in the Consumer Price Index for this Metropolitan Area for calendar year 2023, rounded to the nearest whole dollar; and

**WHEREAS**, the proposed fee adjustments to the Master Schedule of Fees are not subject to the voter approval requirements provisions of Proposition 218.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LA HABRA DOES HEREBY AS FOLLOWS:**

Section 1: The Master Schedule of Fees is hereby amended as per “Attachment A”. The new and revised fees as set forth in “Exhibit A” are hereby approved and adopted by the City Council and shall become effective on July 1, 2024.

Section 2: The Master Schedule of Fees is further amended as per “Exhibit B” relating to building fees.

Section 3: Notwithstanding the provisions of Section 1, in accordance with the California Government Code, the following fees shall not become effective until sixty (60) days from the adoption of this resolution:

Section 3.00 Community Development Fees in its entirety  
Section 6.00 Public Works Fees, Sections 6.10 through 6.27 and  
Sections 6.60 through 6.72.

Section 4: The Master Schedule of Fees is further amended as per County of Orange Health Care Agency – Health Disaster Management Emergency Medical Services relating to Maximum Emergency Ground Ambulance Rates, and ALS Paramedic Assessment and Transportation Fees.

Section 5: The Master Schedule of Fees is further amended as per the County of Los Angeles Fire Code.
