1. STUDY SESSION REGARDING SENATE BILL 1439 (SB 1439)

Assistant City Attorney Keith F. Collins conducted the presentation.

Open dialogue discussion took place with responses provided by Assistant City Attorney Collins.

Maria Mahecha, La Habra resident, spoke.

Councilmember Medrano thanked Assistant City Attorney Collins for the presentation, and commented on SB 1439 applying only to local legislative bodies. He made a motion that staff agendaize for a future City Council Meeting a resolution that reflects City Council's position on Senate Bill 1439 (SB 1439), and advocacy at the League of California Cities conferences that higher-level governing bodies be required to abide by the same accountability. Seconded by Councilmember Gomez.

Moved by Councilmember Gomez, seconded by Councilmember Medrano, and CARRIED UNANIMOUSLY (5-0) THAT CITY COUNCIL RECEIVE AND FILE THE SENATE BILL 1439 (SB 1439) PRESENTATION CONDUCTED BY ASSISTANT CITY ATTORNEY KEITH F. COLLINS.
