

**ORDINANCE NO CC 2024-01**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LA HABRA, CALIFORNIA, AMENDING CHAPTER 12.29 SKATE PARKS OF TITLE 12 STREETS, SIDEWALKS, AND PUBLIC PLACES OF THE LA HABRA MUNICIPAL CODE, REVISING PROVISIONS RELATING TO SKATEPARK DEFINITIONS, PERMISSIONS, AND REGULATIONS

**THE CITY COUNCIL OF THE CITY OF LA HABRA DOES HEREBY ORDAIN AS FOLLOWS:**

**SECTION 1.** The La Habra Municipal Code Section 12.29 is amended as follows:

**§ 12.29.020 Definitions.** – to add non-electric scooters to the definition of “skateboard”.

"Skateboard" shall mean all wheeled objects, coasters, toys, conveyances, *non-electric scooters*, or similar devices used for transportation or sport which are propelled by human power and which are not classified as bicycles.

**§ 12.29.030 Skate parks.** – to amend the person responsible for establishing hours of operations at the Skate Park.

The hours of operation of all skate parks shall be determined by the Director of Community Services or his/her designee and shall be posted at such skate park.

**§ 12.29.040 Skate park regulations.** – to remove the prohibition of food and/or beverage at the Skate Park.

**SECTION 2.** This Ordinance shall take effect and be in force thirty (30) days from the date of its passage, and before the expiration of fifteen (15) days after its passage, it or a summary of it, shall be published once, with the names of the members of the City of La Habra City Council voting for and against the same in the Orange County Register, a newspaper of general circulation published in the County of Orange.
