

**RESOLUTION NO. CC 2024-\_\_\_**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA HABRA, CALIFORNIA, ADOPTING A RESOLUTION IN SUPPORT OF THE HOMELESSNESS, DRUG ADDICTION, AND THEFT REDUCTION ACT, INITIATIVE NO. 23-0017A1**

**WHEREAS**, Prop 47 passed in 2014 with the intent of making California’s criminal justice system more equitable; and

**WHEREAS**, the unintended consequences of Prop 47 include rising—and often organized—retail theft and reducing incentivizes for individuals to seek drug addiction and mental health treatment; and

**WHEREAS**, as Prop 47 was a voter-approved initiative, serious reform must come through a voter initiative; and

**WHEREAS**, the Homelessness Drug Addiction, and Retail Theft Reduction Act is a voter initiative that aims to reform aspects of Prop 47 to address some of its unanticipated consequences; and

**WHEREAS**, the Homelessness Drug Addiction, and Retail Theft Reduction Act aims to reinstate felony convictions for repeat offenders, increase drug and mental health treatment, and enhance penalties for organized theft and destruction of property; and

**WHEREAS**, the Homelessness, Drug Addiction, and Retail Theft Reduction Act is a bi-partisan measure that provides common sense, targeted reforms to Prop 47 that legislative proposals alone are unable to deliver.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LA HABRA, CALIFORNIA DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:**

**SECTION 1.** That the City of La Habra supports Initiative No. 23-0017A1, known as the Homelessness, Drug Addiction, and Retail Theft Reduction Act.
