Hello Leslie,

The City of La Habra Child Development Division requests your approval to complete the following purchase for the City of La Habra Child Development Center Program.

Project: Purchase of two vehicles for the La Habra Child Development

Justification: The La Habra Child Development would like to request the purchase of two vehicles, as listed below. We operate five facilities throughout the City of La Habra, serving approximately 450 students in center-based programs for the La Habra Child Development Division each fiscal year. This includes a Family Child Care Home Network (FCCHN) and a Child and Adult Care Food Program (CACFP), which require daycare home visits and monitoring. We regularly transport various items between locations to support each site, including food, toys, materials, and teaching supplies. Additionally, our staff frequently attend program training and events that necessitate traveling to multiple locations.

For Vehicle #1, we propose acquiring a Ford Explorer, with an estimated CCTR apportionment cost of 47% of the total, amounting to \$20,120.59.

For Vehicle #2, we propose acquiring a Ford F-150, with an estimated CCTR apportionment cost of 60%, totaling \$23,123.53

The total cost for the CCTR apportionment is **\$ 43,244.12**

This purchase will improve accessibility to each site, enhance site-to-site coordination of activities and events, and align with our objective of delivering quality care and educational services for the children in our care. **Procurement policies and procedures for the City of La Habra will be adhered to when purchasing the above items and will be received by June 30, 2025.**
