

RESOLUTION NO. CC 2025-__ & UA 2025-__

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA HABRA, CALIFORNIA, AND THE LA HABRA UTILITY AUTHORITY APPROVING AND ADOPTING A CROSS-CONNECTION CONTROL MANAGEMENT PLAN

The City Council of the City of La Habra and the La Habra Utility Authority do hereby resolve as follows:

SECTION I:

WHEREAS, on December 19, 2023, in accordance with Health and Safety Code Section 116407, the State Water Resources Control Board (“State Water Board”) adopted a Cross-Connection Policy Handbook (“CCCPH”) to establish standards and principles for California’s public water systems; and

WHEREAS, on March 19, 2025, the State Water Board amended the CCCPH to impose deadlines on public water systems to develop, submit, and implement a Cross-Connection Control Management Plan no later than July 1, 2025; and

WHEREAS, the Utility Authority has prepared a Cross-Connection Control Management Plan in accordance with the CCCPH.

SECTION II:

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of La Habra and the Directors of the La Habra Utility Authority, to ensure the elimination and prevention of cross-connections between sources of water that are not approved as safe and potable for human consumption, and to comply with the requirements of the State Water Board’s CCCPH, hereby approve the City of La Habra Cross-Connection Control Management Plan.
