**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
LA HABRA, CALIFORNIA, AND THE LA HABRA UTILITY
AUTHORITY APPROVING AND ADOPTING A SEWER
SYSTEM MANAGEMENT PLAN UPDATE**

The City Council of the City of La Habra and the La Habra Utility Authority do hereby resolve as follows:

SECTION I:

WHEREAS, on May 2, 2006, the State Water Resources Control Board (SWRCB) adopted Order No. 2006-003-DWQ (Order), which established General Waste Discharge Requirements (WDRs) for all publicly owned/operated sanitary sewer collections systems within the State of California, and required each system to develop and implement a Sanitary System Management Plan (SSMP) detailing how the system is operated, maintained, repaired and funded; and

WHEREAS, the Utility Authority developed an SSMP in accordance the Order, and the SSMP was approved by La Habra City Council on August 17, 2009; and

WHEREAS, on December 6, 2022, the SWRCB adopted Order No. WQ 2022-0103-DWQ (General Order), updating the requirements of the WDR to include updates to the SSMP every six (6) years and internal audits of the SSMP every three (3) years; and

WHEREAS, the City last updated its SSMP in December 2019 with internal audits completed in 2022 and 2025; and

WHEREAS, the Utility Authority has prepared an SSMP update in accordance with the SWRCB's General Order.

SECTION II:

NOW, THEREFORE, BE IT RESOLVED by the City Council Members of the City of La Habra and the Directors of the La Habra Utility Authority, to ensure the proper operation of the City's sanitary sewer system, to prevent sewer spills, and to comply with the requirements of the State Water Resources Control Board's Order No. WQ 2022-0103-DWQ, hereby approve the City of La Habra Sanitary Sewer Management Plan Update.
