**PUBLIC HEARINGS**

1. DULY NOTICED PUBLIC HEARING FOR CONSIDERATION OF A REQUEST FOR CONDITIONAL USE PERMIT 25-0011 FOR PUBLIC ART (MURAL) AT 100 WEST LA HABRA BOULEVARD.

Chair Mahecha asked if any correspondence had been received with regard to the item. Secretary Lopez said no.

Planning Manager, Soya Lui, presented the staff report.

Chair Mahecha asked if any of the Commissioners had any questions. After acknowledging that the other Commissioners did not have questions, Chair Mahecha asked about the cost of the mural. Deputy Director of Community Services, Kim Alberian, addressed the Commission and explained that it will cost \$20,000 to design and implement the mural.

Director Kim, reminded the Commission that they were there to review and approve the use only and not the cost of the work.

Moved by Vice Chair Ramsland and seconded by Commissioner Logan-Cannon, approving Resolution No. 25-14 Entitled: A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF LA HABRA, CALIFORNIA, MAKING THE REQUIRED FINDINGS AND APPROVING CONDITIONAL USE PERMIT 25-0011 TO ALLOW THE INSTALLATION OF PUBLIC ART (MURAL) ON AN EXISTING COMMERCIAL BUILDING LOCATED AT 100 WEST LA HABRA BOULEVARD, SUBJECT TO CONDITIONS, AND MAKING THE DETERMINATION THAT THE PROJECT IS EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) PURSUANT TO SECTION 15301, CLASS 1: "EXISTING FACILITIES" OF THE CEQA GUIDELINES.
