PUBLIC HEARINGS

- 1. DULY NOTICED PUBLIC HEARING TO CONSIDER A REQUEST FOR CONDITIONAL USE PERMIT 25-0008 (CUP25-0008) TO ALLOW ALCOHOLIC BEVERAGE SALES AT AN EXISTING GENERAL RETAIL USE (7-ELEVEN), LOCATED AT 381 EAST WHITTIER BOULEVARD (ASSESSORS PARCEL NUMBER 017-303-45), UNDER A TYPE 21 (OFF-SALE GENERAL) ALCOHOLIC BEVERAGE CONTROL (ABC) LICENSE

Chair Mahecha asked if any correspondence had been received with regard to the item.

Secretary Lopez said no.

Contract Planner, Darryl Taylor, presented the report.

Chair Mahecha asked if any of the Commissioners had questions for staff.

Vice Chair Ramsland asked if staff knew what kind of new alcohol they would be selling since the allocated storage space seemed very small. Contract Planner Taylor deferred that question to the applicant.

Chair Mahecha opened the public hearing and asked if there was anyone wishing to speak in favor of the item.

Bruce Evans, representing the applicant, addressed the Commission. Mr. Evans introduced other members of his party who were present including the franchisee. Mr. Evans thanked Darryl for his responses. He explained that they had reached out to La Habra Police before submitting their application and that the La Habra Police did not have any issues. He answered Vice Chair Ramsland's question by stating that 7-Eleven is proposing to offer standard alcohol spirits such as whisky, vodka and rum. Mr. Evans also confirmed that the conditions of approval were acceptable.

Vice Chair Ramsland questioned if the applicant was proposing any extra security measures for the evening hours. Mr. Evans said no in light of the fact that the La Habra Police did not express any concerns and their business is already equipped with a good security camera system.

Chair Mahecha asked Mr. Evans if he knew how much more tax revenue would come out of the sales of these alcohol spirits. Mr. Evans said he didn't know the exact amount, but said it would be a modest bump and explained that 7-Eleven corporate is working with the franchisees to allow them to provide extra products such as this to help increase sales.

Vice Chair Ramsland asked if the condition of approval requiring an onsite manager at all times and providing the managers information onsite would be an issue. Mr. Evans said that they will designate an onsite manager during the various shifts throughout the entire day. Each employee is also trained to comply with Alcohol Beverage Control's regulations and with the security system.

Mr. Richard Flores, resident at 615 Hillcrest St., addressed the Commission. Mr. Flores said that he has been shopping at this 7-Eleven for the past 43 years. He spoke favorably of the employees who work at this store and said they run a clean operation.

Chair Mahecha asked if there was anyone wishing to speak in opposition of the item. There were none.

Chair Mahecha closed the public hearing and asked for a discussion or a motion.
