

**AMENDMENT NO. 2 TO  
AGREEMENT FOR SERVICES**

This Amendment No. 2 (“Amendment”) to the Agreement for Services is made and entered into effective the 16th day of March, 2026 by and between the CITY OF LA HABRA, a Municipal Corporation (“CITY”), and JOHN L. HUNTER & ASSOCIATES, INC. (hereinafter “CONSULTANT”). CITY and CONSULTANT are sometimes hereinafter individually referred to as “Party” and or collectively referred to as the “Parties.”

**A. Recitals.**

(i) CITY and CONSULTANT entered into a Professional Services Agreement (“Agreement”) effective June 15, 2020 through which CONSULTANT has been providing professional services as more fully explained in the Scope of Services attached to the Agreement as Exhibit “A”.

(ii) The Parties executed Amendment No. 1 to the Agreement effective June 30, 2025, to extend the term of the Agreement to June 30, 2026.

(iii) The Parties now seek to amend the Agreement to extend the term of the Agreement to June 30, 2027.

(iv) All legal prerequisites to the making of this Amendment have occurred.

NOW, THEREFORE, in consideration of the mutual covenants and conditions set forth herein, the Parties agree as follows:

**B. Amendment to Agreement.**

1. Section 1.2 of the Agreement is hereby amended to read as follows:

The term of this Agreement shall begin on July 1, 2020 and continue until completion of the work on June 30, 2027 and its final acceptance by the CITY, or until such time as it is terminated pursuant to the provisions of this Agreement.

2. Except as specifically modified herein, all of the terms, conditions and provisions of the Agreement shall remain in full force and effect.



The Agreement, all amendments together with this Amendment No. 2 and all Exhibits attached thereto, constitutes the entire Agreement between the Parties and supersedes all prior negotiations, arrangements, representations, and understandings, if any, made by or between the Parties with respect to the subject matter hereof. No amendment or other modification of the Agreement, as modified by this Amendment No. 2 shall be binding unless executed in writing by both Parties hereto, or their respective successors, assigns, or grantees.

4. Each of the undersigned represents and warrants that he or she is duly authorized to execute and deliver this Amendment No. 2 and that such execution is binding upon the entity for which he or she is executing this document.
