 5. Such rate modifications as may be calculated in 3 and 4 above shall be made to the nearest one cent (\$0.01).
 6. The "Readiness to serve" portion of the minimum charge as established in Section 3 shall be modified effective each July 1st by a percentage equal to the percentage change in the Consumer Price Index the preceding May to the same period of the prior year.

8. The City Manager shall likewise concurrently file with the City Council a report including such other recommendations relative to recovering costs of service as he deems necessary.
