C. Orange Tree Painting Volunteer Project

Public Works Director Kyle Ames informed the Commissioners that local Scout troops recently contacted him about community service opportunities. In past years they volunteered to help paint the City's orange trees. This was a fun and successful community beautification project that some of our RPG Commissioners also helped with. Discussion was held. The Commissioners agreed to hold a tree painting event the weekend of March 18 and 19, 2023. Staff and Commissioners will reach out residents and local schools, churches, troops, and service organizations to enlist volunteers. D. Pickleball Courts at Scout Park

Commissioner Fix has been approached by several residents about the lack of pickleball courts in the City. She compiled a list of West Valley pickleball courts for the Commission's reference. There are pickleball courts at The Wigwam for members. There are also pay-to play pickleball courts at the Rec Center. However, there are no free public pickleball courts in Litchfield Park. Commissioner Fix believes that Scout Park would be an ideal place to install at least two pickleball courts. Discussion was held about proposed plans for Scout Lodge and Litchfield Square that should be taken into consideration. Commissioner Culbreth would like Camelback Park to be considered as a possible location. Public Works Director Kyle Ames offered to research the space needed and costs involved with installing four pickleball courts. No action was taken at this time.

E. Trees at Tierra Verde Lake Park

Commissioner Gerz told the Commission he suspects that some of the trees at Tierra Verde Lake Park are being impacted by waterfowl roosting. He wants to know if his suspicions are correct and if there is anything that can be done about it. Public Works Director Kyle Ames informed the Commission that nonmigratory cormorants are the waterbirds causing the problems. This is an ongoing issue, so Director Ames reached out to the Arizona Game and Fish Department. They informed him there is nothing effective that can be done. Mr. Ames offered to reach out to neighboring cities to see if they are having similar problems and, if so, what they are doing about it. No action was taken at this time.

F. Converting Grassy Common Areas to Desert Landscaping

Commissioner Gerz wanted to know if the Commission should come up with a policy outlining the conditions that would lead to an open space being converted from grass to desert landscaping. Commissioner Gerz suggested that the criteria include the survivability of existing trees, as well as proximity to other grassy areas. The policy could also take into consideration future water restrictions imposed by the State. Discussion was held. The Commission would like to know if this is something they should pursue. Staff will follow up with the City Manager and report back to the Commission. No action was taken at this time.

Mr. Ames reviewed his report with nothing further to add.

B. Community and Recreation Services Monthly Report

Ms. Kramer reviewed her report. She added that the online signup form for the April 22 Community Garage Sale has opened. She encouraged the Commissioners to pass this information along to interested residents.
