

PROJECT: Discussion regarding Development Officer job description

to include Health Inspections

DESCRIPTION: The development officer position and job responsibilities were

presented and approved by Town Council during the 2012 FY budget process. Over the last year Development Services has been reviewing our Health Inspection process and procedures. We have looked at several options, what process and fees other cities have, and the costs for in-house vs. consultants. During the recent interview process for the development officer position, which will be performing rental inspections, commercial site inspections, and various zoning related codes, staff came across an applicant that can perform these duties and

perform Health Inspections.

Staff would like to improve the health inspection process and believe the cheapest most effective way would be to expand the job duties of the development officer position which would cause a change in the pay plan approved by Council for the position to grade P, step 2. Overall it would be a savings to the budget and not require a budget amendment. The pay plan adjustment would be approximately \$8,000 while the annual cost for the Health Contract is \$20,000 (see attached chart). The Town would still contract out for occasionally for septic inspections which have been less than \$1,000 a year for the last three years.
