Dear Ms. Hadidi:

This letter provides clarification regarding the unique attributes of the 24-Hour Library proposed by John Himes as an upgrade to your existing EnvisionWare system.

EnvisionWare is *unique* in the library community as the only vendor that provides a level of comprehensive services aimed at public library self-service and operational efficiency. As a customer using EnvisionWare time and print management, you already know about the focus on patron self-service with intuitive designs that can free staff from tedious, repetitive tasks and empower patrons to do more for themselves.

EnvisionWare created a market for a free-standing, self-service remote 'branch' with the introduction of the 24-Hour Library, the first system successfully deployed to expand the reach of the library into underserved areas that cannot justify the expense of a brick-and-mortar branch. In keeping with EnvisionWare's principles of making the most of any investment, the system offers a broad range of services which make it peerless in the library community.

The 24-Hour Library's *unique array of services* include:

- **Full patron circulation experience:** Patrons can check in, check out, browse, return, and renew items (including items not present), 24 hours a day, 7 days a week.
- **Checkout of electronic resources:** The 24-Hour Library uniquely brings digital media to your patrons. You can setup the program display as a browsing station for eBooks and use the incorporated Wi-Fi for patrons to select and download electronic resources. This brings a plethora of new titles into the hands of your users and again replicates traditional library services into a self-service location.
- **Pay fines and fees (optional):** The optional payment system can be used to unblock 24-Hour Library users that owe fines over the threshold. It can also be used for patrons to place funds on deposit, which can then be used with all EnvisionWare self-service applications to pay for printing, copying, faxing, scanning and fine payment. In addition, the credit card terminals can be integrated into our library point of sale system.
- **Hold pickup management:** As a patron enters his or her library card, the system detects the presence of one or more holds for them. In the fully automated mode, the system starts dispensing all that user's holds. If the user doesn't want a title, they can instantly return the item. By dispensing all holds for that borrower (rather than asking a patron to pick each hold item he or she wants to dispense) items flow through the holds queue more quickly, rather than sitting on the shelf until they expire.
- **Automated expired hold management:** If a hold expires and the user has not picked up the requested item, the system will automatically dispense the expired item(s) into a specific bin. This automated process frees staff from the tedium of pulling holds.



- **Multi-user functionality:** One of the most powerful and unique attributes is multi-user visual browsing. Multiple users can scan the shelves to see the book spines, meaning that more than one person can engage with the system at a time. In fact, several people can browse while one is checking out and another is downloading an eBook.
- **Internet access:** The 24-Hour Library comes with a 2-channel Wi-Fi access point. One channel can be open to the public, replicating the same Internet access that is available at your existing libraries. The other is a VPN to be used by staff if they come to the site to conduct a registration or outreach event.
- **Automated material sorting:** The 24-Hour Library is the only system that incorporates a complete automated materials handling system. It can sort returns to make pickup of materials a seamless experience. Furthermore, the cost of a stand-alone AMH system is about equal to the price of the complete 24-Hour Library, illustrating considerable value.
- **Library branding, marketing, and promotion:** The system has lightboxes to provide bright and engaging library branding. EnvisionWare creates the film from the artwork provided by the library. Additionally, EnvisionWare's unique Library Marketing Kits provide materials for signage including recommendations for road sign designs that can lead patrons to the new 24-Hour Library location.
- **Security monitoring and recording:** The 24-Hour Library includes external and internal cameras and a 30-day DVR so you can watch activities from a remote location. EnvisionWare support can look at a recording from the internal camera to diagnose technical issues.
- **Firewall protection:** A complete router/firewall is included in the system to ensure optimal security, setup of a VPN for secure staff communications, and seamless integration with the library's network.
- **EnvisionWare exceptional in-house installation, service, and support:** The entire implementation process is high-touch. A consultant will be assigned to oversee the entire project. The Site Planning Guide available in the Customer Center, coupled with the consultant's experience at installing these systems across North America, ensures a successful end-to-end experience. This covers planning and preparation of the foundation and covering to the final delivery and setup of the system. Upon purchasing, the Professional Services team schedules an on-site session to train staff in the differences between traditional branch operation and 24-Hour Library management. This covers everything from how holds are uniquely managed to how to change the setup of the ILS for hold notifications. The 24-Hour Library arrives pre-configured and pre-tested. It is bolted to the slab in compliance with earthquake guidelines. Seamless integration also means a single point of contact for service. You have the assurance of a stellar experience for installation and ongoing exceptional customer service experiences.
