RESOLUTION TIRZ #3 0418202301T3

A RESOLUTION OF THE BOARD OF DIRECTORS OF TAX INCREMENT REINVESTMENT ZONE NUMBER THREE, TOWN OF LITTLE ELM, TEXAS, APPROVING CERTAIN PROJECT EXPENDITURES; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town of Little Elm, Texas (hereinafter referred to as the "Town"), pursuant to Chapter 311 of the Texas Tax Code, as amended (hereinafter referred to as the "Act"), may designate a geographic area within the Town as a tax increment reinvestment zone if the area satisfies the requirements of the Act; and

WHEREAS, on April 15, 2014, pursuant to and as required by the Act, the governing body of the Town (hereinafter referred to as the "Town Council") approved and adopted by Ordinance No. 1214, a *Final Reinvestment Zone Financing Plan for Tax Increment Reinvestment Zone Number Three, Town of Little Elm, Texas*, and a *Final Project Plan*, for a tax increment reinvestment zone containing approximately 847 acres of property located within the Town of Little Elm, Texas; and

WHEREAS, the Board of Directors of Reinvestment Zone Number Three, Town of Little Elm, Texas, originally approved the FY 2022-2023 budget through Resolution No. 0906202201T3 and now desires to authorize through the passage of Resolution No. 0418202301T3 on April 18, 2023, certain expenditures (1) increase incentive pay for a total of \$150,000; all of which the Board found were authorized expenditures under the Act; and

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF TAX INCREMENT REINVESTMENT ZONE NUMBER THREE OF THE TOWN OF LITTLE ELM, TEXAS:

SECTION 1. The findings set forth above are incorporated into the body of this Resolution as if fully set forth herein.

SECTION 2. the Board of Directors of Reinvestment Zone Number Three, Town of Little Elm, Texas, in accordance with the Act, hereby authorize certain (1) increase incentive pay for a total of \$150,000.

SECTION 3. That if any section, article paragraph, sentence, clause, phrase or word in this Resolution, or the application thereto to any persons or circumstances, is held invalid or unconstitutional by a Court of competent jurisdiction, such holding shall not affect the validity of the remaining portions of this Resolution; and the Board of Directors hereby declares it would have passed such remaining portions of this Resolution despite such invalidity, which remaining portions shall remain in full force and effect.

SECTION 4. That this Resolution shall become effective from and after its date of passage in accordance with law.

AGENDA ITEM:

Present, Discuss and Consider Action to Approve the **Termination Agreement between TIRZ #3 and 100 Hardwicke, LLC.**

DESCRIPTION:

This Termination Agreement terminates the original Reimbursement Agreement, executed August 2022, between TIRZ #3 and 100 Hardwicke, LLC for the annual payments of Twenty Five Thousand and No/100 Dollars (\$25,000) for the term of six (6) years, total amount not to exceed One Hundred Fifty Thousand and No/100 Dollars (\$150,000).

BUDGET IMPACT:

The Termination Agreement concludes the \$25,000 annual payment for six (6) years, less one payment, already paid to 100 Hardwicke, LLC for the 2022 year. No further payments will be made after the execution of this agreement.

RECOMMENDED ACTION:

Staff recommends approval of the Termination Agreement as presented.

TERMINATION OF REIMBURSEMENT AGREEMENT

RECITALS:

WHEREAS, on or about August 16, 2022, TIRZ # 3 and Developer entered into the original Reimbursement Agreement (the "Original Agreement") concerning the payment of a grant amount of One Hundred Fifty Thousand and No/100 Dollars (\$150,000.00) paid in annual amounts of Twenty-Five Thousand and No/100 Dollars (\$25,000.00) per year for a six (6) year period (the "Grant Amount"); and

WHEREAS, consistent with the terms of the Original Agreement, TIRZ # 3 made an initial payment of Twenty-Five Thousand and No/100 Dollars (\$25,000.00) to Developer; and

WHEREAS, TIRZ # 3 and the Developer now desire to terminate and release the parties of the obligations contained in the Original Agreement, including the payment of the remaining balance of One Hundred Twenty-Five Thousand and No/100 Dollars (\$125,000.00) of the Grant Amount to Developer, by approving this Termination Agreement.

NOW, THEREFORE, for and in consideration of the foregoing premises and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, TIRZ # 3 and Developer covenant and agree as follows:

SECTION 1. FINDINGS INCORPORATED.

The foregoing recitals are hereby incorporated into the body of this Termination Agreement and shall be considered part of the mutual covenants, consideration and promises that bind the parties.

SECTION 2. TERMINATION OF ORIGINAL AGREEMENT AND ANY AMENDMENTS.

- (a) The Original Agreement and any amendments related thereto by and between TIRZ # 3 and the Developer is hereby terminated.
- (b) TIRZ # 3 and the Developer covenant and agree that each party shall have no further obligation to the other party under the Original Agreement and any amendments related thereto.

IN WITNESS WHEREOF, the parties hereto have executed this Termination of Reimbursement Agreement and Performance Agreement on the day and year first above-written.
