II. MATTERS FOR DISCUSSION



Discussion: This was the lowest and best quote received. This was approved by Ordinance #196-25 attached to these minutes as exhibit A.


Mayor Bradley made the motion to approve the request; Safety/Service Director Carrion seconded the motion.

Roll Call: Safety/Service Director Carrion-aye; Mayor Bradley-aye. Motion carried unanimously.

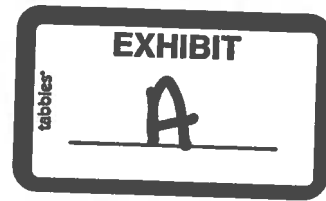

ORDINANCE NO: 196-25

AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY/SERVICE TO PURCHASE GASOLINE, FUEL, OIL, AND OTHER PETROLEUM PRODUCTS ALL NEEDED FOR VARIOUS CITY DEPARTMENTS AS LISTED IN SECTION 1, THROUGH THE STATE OF OHIO COOPERATIVE PURCHASING PROGRAM, OR FROM A VENDOR WHOSE PRICING IS AT OR BELOW OHIO STATE TERM PRICING, WITHOUT BID, PURSUANT TO RC SECTION 735.053, COMMENCING JANUARY 1, 2026, AND ENDING DECEMBER 31, 2026.

WHEREAS, The current contract for petroleum products for the City of Lorain will expire on December 31, 2025.

WHEREAS, Ohio Revised Code Section 735.053 provides that contracts for equipment, services, materials, or supplies to be purchased under Section 125.04 of the Ohio Revised Code ("State Purchasing") do not require competitive bids to be advertised for and obtained.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LORAIN, STATE OF OHIO:

SECTION I. The Director of Public Safety/Service is hereby authorized and directed to purchase gasoline, fuel, oil, and other petroleum products as required by various departments of the City of Lorain, such as the City Garage, Parks, Water, Police, Fire, Building and Planning, Street, and Sewer Departments, for a period of twelve (12) months, through the State of Ohio Cooperative Purchasing Program, or from a vendor whose pricing is at or below said state term pricing, without not to exceed eight hundred twenty-five thousand bid, for an amount dollars (\$825,000.00) pursuant to Ohio Revised Code Section 735.053, subject to authorized appropriation by City Council.

SECTION II. That the cost of gasoline, fuel, oil, and other petroleum products shall be taken from account number 7010.1701.6400.3400 Petroleum Supplies For Sale in the amount of \$825,000.00.

SECTION III It is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public and in compliance with all legal requirements, including 121.22, Ohio Revised Code.

SECTION IV. That this Ordinance shall be in force from and after the earliest period allowed by law.

AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY/SERVICE TO PURCHASE GASOLINE, FUEL, OIL, AND OTHER PETROLEUM PRODUCTS ALL NEEDED FOR VARIOUS CITY DEPARTMENTS AS LISTED IN SECTION I, THROUGH THE STATE OF OHIO COOPERATIVE PURCHASING PROGRAM, OR FROM A VENDOR WHOSE PRICING IS AT OR BELOW OHIO STATE TERM PRICING, WITHOUT BID, PURSUANT TO RC SECTION 735.053, COMMENCING JANUARY 1, 2025 AND ENDING DECEMBER 31, 2026.

PURPOSE AND BACKGROUND:

To allow the City of Lorain to purchase petroleum and petroleum products through the State of Ohio Cooperative Purchasing Program or from a vendor whose pricing is at or below that State of Ohio term pricing, without bid, to satisfy the fuel needs of City of Lorain for 2026.
