- 1. The Board reviewed the current process of expired Special Permits.
- o The Board, with the assistance of the Planning Board members, reviewed the renewal process of Special Permits.
- o It is the responsibility of the applicants to renew their special permits.
- The Building Department has not been enforcing the violations or fining violations for expired Special Permits.
- Dan Segal, Village Director of Planning, will revise the original letter for the renewal of Special Permits to reflect the changes made tonight to be sent out to applicants. The letter is to be circulated to Broad members for edits and then the Board will vote on it.
- O The Planning Department will send out letters to all businesses that have had their Special Permits expired. They will either get a follow-up letter or a new letter being told that if they want to renew their Special Permit they must file their application 4 months of the date of the letter. After 4 months, you will have to file a new Special Permit.
- The letter will state that the applicant is also asking for a renewal Special Permit and an extension of time to file the application.
- This policy will not apply to any Special Permit that was issued on or after 3 years from before today January 2nd, 2025.
- o Applying for an extension of time for good cause language needs to be added for the renewal.
