Review

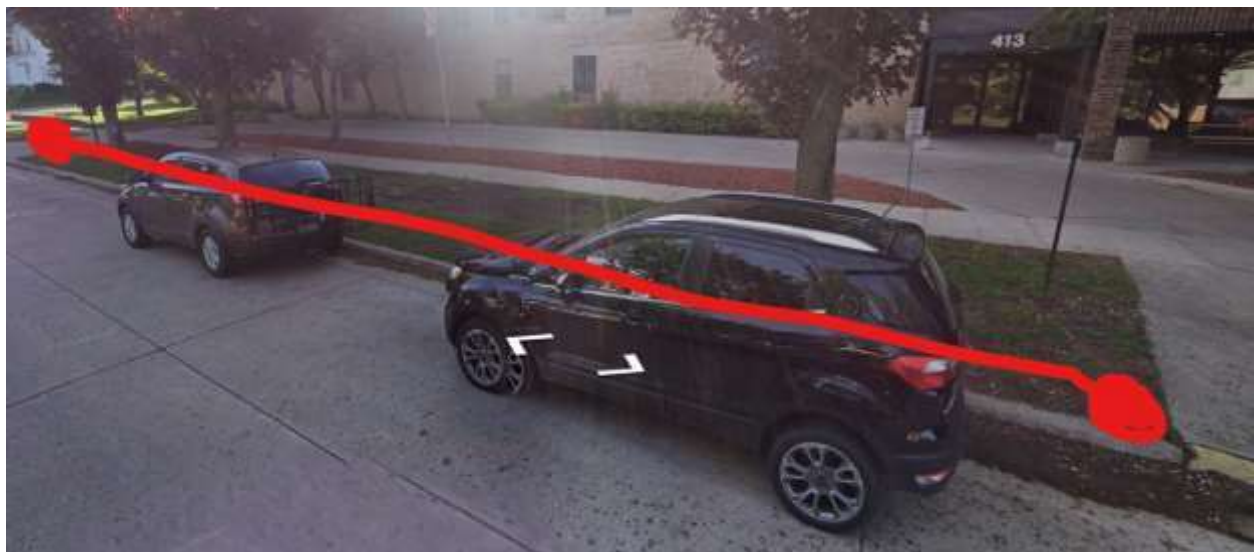
