

AMENDMENT TO VEHICLE TOWING SERVICES AGREEMENT

This Amendment (the "Amendment") is to the Vehicle Towing Services Agreement last dated February 23, 2023 (the "Agreement") by and between the City of Mankato, Minnesota (the "City") and Affordable Towing (the "Company").

1. Renewal Term

The City and the Company hereby exercise their option to renew the Agreement for an additional two (2) year term (the "Renewal Term") commencing on January 14, 2026 and ending on January 13, 2028.

2. Successive One-Year Terms

Upon expiration of the Renewal Term, the Agreement shall automatically continue for successive one (1) year terms unless either party provides written notice of termination at least 60 days prior to the expiration of the then-current term.

3. Modification of Towing Charges

The towing charges set forth in the Agreement are hereby revised and replaced with the charges listed in Exhibit A attached to and incorporated into this Amendment.

4. Future Charge Adjustments

From time to time, the towing charges may be modified upon the written agreement of the City Manager and the Company. Any such modification shall be documented in writing and appended to the Agreement.

5. Modification of Insurance Requirements.

The following language shall be deleted in Section 8.a of the Agreement: "Liability minimums shall be: three hundred thousand (\$300,000) dollars personal liability per person, per occurrence and a total of one million (\$1,000,000) dollars per occurrence." All other insurance requirements in the Agreement shall remain in effect.

6. No Other Changes

Except as expressly amended herein, all terms and conditions of the Agreement remain in full force and effect.
