SUMMARY MINUTES

CALL TO ORDER ROLL CALL

Facilitator Andrea De La Cruz called the meeting to order at 4:05 PM

ROLL CALL

Ms. De La Cruz called the roll. Committee Member, **Development Services Jason Angell** was absent. **Vic Hathaway** was not in attendance for the roll call, she arrived at 4:10PM. All other Committee Members were present, constituting a quorum.

APPROVAL OF AGENDA

Committee Member Craig moved to approve the agenda as presented. Committee Member Fausto seconded the motion. Motion passed, 5-0.

APPROVAL OF MINUTES

APPROVAL OF MINUTES FROM August 25, 2025

Committee Member Fausto moved to approve the minutes as presented. Committee Member Craig seconded the motion. Motion passed, 5-0.

ANNOUNCEMENTS

Ms. De La Cruz announced that the Request for Proposals (RFP) for the Mural Project on the water tower located on Twin Peaks Road near Dove Mountain has been posted and will close on October 23, 2025. She reported that there has already been some interest and is hopeful the committee will receive several proposals.

Ms. De La Cruz also announced that the Marana Town Council approved the Committee's recommendation to install a rattlesnake art sculpture at Rattlesnake Pass along Twin Peaks Road.

GENERAL ORDER OF BUSINESS

A. Discussion and feedback on the draft of the Request for Proposals (RFP) scope for a public art installation at El Rio Preserve.

Committee Member De La Cruz provided a draft of the RFP for the committee to review and discuss potential revisions. After some discussion, the committee agreed that two changes should be made under the "Purpose" section: remove the second bullet point, "reflect the cultural heritage and historic layers of the area," and add a reference to highlighting birds in the sculpture.

Committee Member Craig moved to approve the RFP with the recommended revisions to the "Purpose" section, specifically removing the second bullet point and adding a reference to the importance of and relating to birds in the first bullet point. Committee Member Barnett seconded the motion. Motion passed 6-0

FUTURE AGENDA ITEMS

Ms. De La Cruz would like to discuss the Water Tower Mural and the next major art project which could also be part of the next TABY Grant.

ADJOURNMENT

Ms. De La Cruz asked for a motion to adjourn the meeting. Committee Member Hathaway motioned to adjourn the meeting. Committee Member Burrue seconded the motion. Motion passed, 6-0. Meeting was adjourned at 4:35pm.
