**Town Attorney Jane Fairall** presented on this item. She stated that the original agreement was entered into in 2008 and first amended in 2019. **Ms. Fairall** explained that the proposed amendment addressed three primary items: increasing the not-to-exceed total aggregate principal amount of developer bonds from \$20 million to \$32 million to accommodate increased infrastructure and construction costs; extending the timeframe for debt issuance to January 1, 2034; and extending the termination date of the agreement to February 1, 2059.

*Vice Chair Ziegler moved to adopt Resolution No. GFCFD2 2026-001. Board Member Comerford seconded the motion. Motion passed, 5-0.*
