The note was secured by a first priority security interest of all proceeds from fees and net earnings from the Muskogee Music Festival. Note is due and payable on July 1, 2018. On November 14, 2017, the City of Muskogee received a disbursement of funds from the Muskogee Regional Medical Center in the amount of \$1,063,424.00
