Assistant City Attorney Matt Beese stated the City of Muskogee is the Beneficiary of the Muskogee War Memorial Park Trust Authority, therefore any proposed changes by the Trust are ultimately decided upon by the Mayor and City Council. Mr. Beese distributed a copy of the proposed changes to the Trustees present. He explained the Trust consists of nine (9) Trustees. Based upon the proposed changes, six (6) Trustees would be appointed by the Mayor and approved by City Council, thus giving the Trustees the authority to recommend the three (3) remaining Trustees. At that point, the City Council would then ratify those appointments. He explained that according to State Law, Trusts can no longer make their own appointments; the Beneficiaries must approve them. Based upon the current City Council Board Appointment Rotation Process, every third appointment would then be awarded to the Trustees for final City Council approval.

At this stage, the Trustees will need to review and approve the proposed changes and present those changes to the City Council. The City Council will vote on whether to approve or deny the proposed changes.
