Assistant City Manager Gary Garvin stated Muskogee-Davis Regional Airport has been grateful to host the Commemorative Air Force (CAF) Air Power Tour on several occasions in the past five (5) years. This year, the CAF wants to co-sponsor an event with the Military & Indian Aviation Heritage Foundation (MIA) called "Bombers, Blues, & BBQ." Tentatively, the CAF plans to bring the B-29 Superfortress, B-24

Liberator, and several other aircraft including some from the Cavanaugh Flight Museum. The MIA Foundation will be coordinating the accompanying entertainment to include but not limited to live music, food, topical speakers, a fly-in with pancake breakfast, and evening fireworks. The event plans and schedule must be fluid and may change based on aircraft availability, weather, and etcetera. The MIA Foundation is a 501c(3) and money raised through this event will go towards restoration of the original Muskogee WWII hangar located at our airport. The Airport Board did recommend approval at their last meeting.

Approve the Final Plat of Walnut Creek Addition.

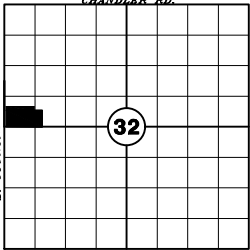

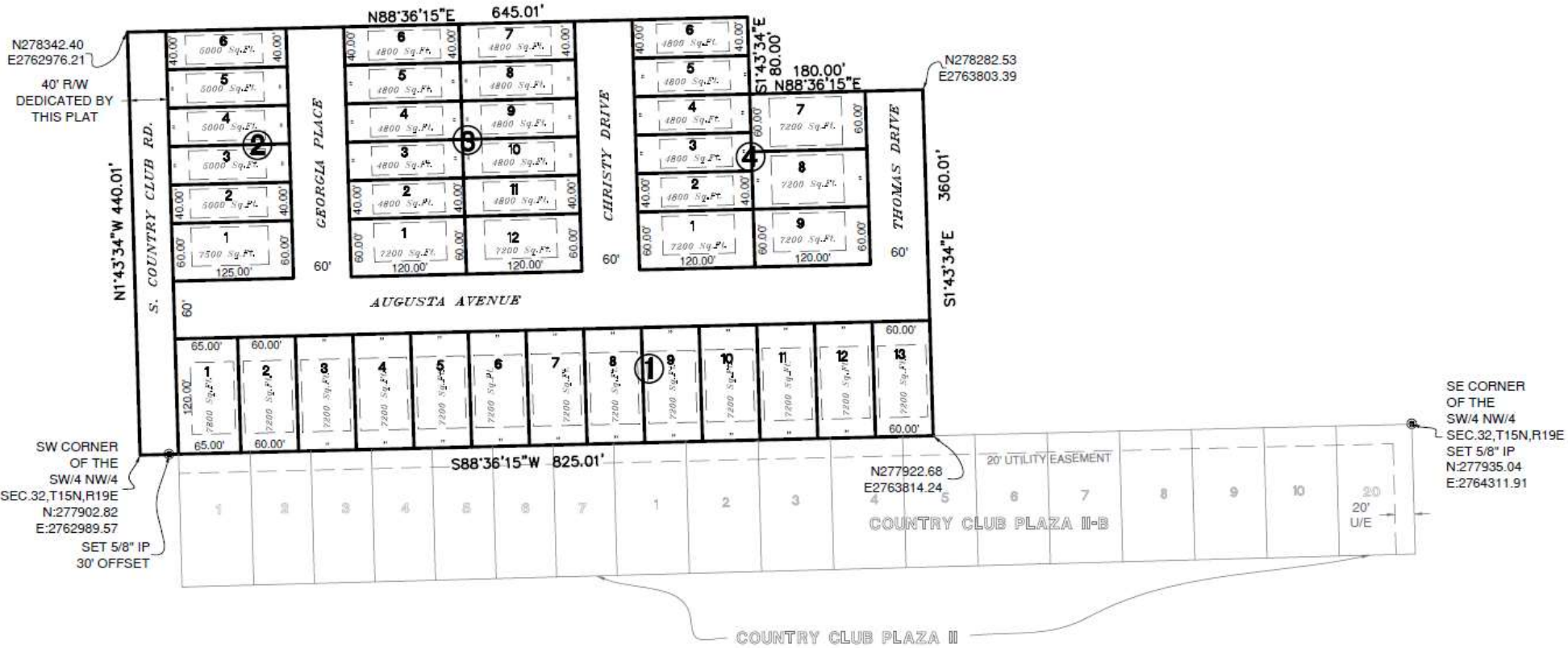
