#### **BACKGROUND:**

In April of 1984, an Urban Renewal Plan was developed titled the Muskogee Downtown Revitalization and Neighborhood Development Project. This Plan outlined certain boundaries, restrictions and permitted uses for the urban renewal area. There were restrictions placed on the Arrowhead Mall property which required that it be maintained as a regional shopping mall with associated parking. Numerous malls across the United States are vacant and not being used for their original intended purpose. In lifting these restrictions established in 1984, the Arrowhead Mall may be able to convert its space to a more modern, functioning place of business, whether that is in the form of offices, downtown apartments, or other avenues which generate sales tax or downtown foot traffic.
