Public Works Director Mike Stewart stated this Consent Order was issued as a result of damage sustained at the Sewer Treatment Plant during the 2019 flood. The City was fined \$50,000.00. At the time of issuance, the City agreed to pay \$25,000.00 up front, then proceed with an SEP project for an additional \$25,000.00. It was a requirement the money be used for a Stormwater or Sanitary Sewer project. It was agreed the City would build an impervious parking lot. However, in order to do so, property belonging to OG&E needed to be acquired. Since that time, negotiations for acquiring the property have been ongoing with no agreement. It is Staff's recommendation to continue the project, but close out the Consent Order by paying the additional \$25,000.00 for the fine.
