Beginning at the Southeast corner of the said SW/4, thence S87°54'42"W along the south line thereof 2370.50 feet to a point on Easterly Right of Way line of the M.K.&T Railroad (now Union Pacific Railroad), thence along said right of way N29°44'59"E 202.76 feet to a point of curve, thence on a curve having a chord bearing of N33°36'55"E 1150.68 feet, and a radius of 11359.20 feet, a arc distance of 1151.17 feet, thence N35°39'48"E 1934.69 feet to a point on the North line of said SW/4, thence N87°49'57"E 435.52 feet to the Northeast corner of said SW/4, thence S01°28'47"E 2637.12 feet to the point of Beginning containing 86.76 acres.

<u>Section 2:</u> The zoning classification of the real estate hereinbefore described in Muskogee County will be zoned in accordance with Ordinance 3948-A upon annexation.

Section 3: The increase of the City by the annexation of the hereinbefore described

property will redound to the benefit of the City and the same is hereby zoned and annexed.

Section 4: A copy of the Ordinance, together with an accurate map of the territory zoned and annexed, certified by the Mayor and the City Clerk, shall be filed in the office of the County Clerk of Muskogee County, Oklahoma.

<u>Section 5:</u> SEVERABILITY. Should any section, subsection, sentence, provision, clause, or phrase hereof be held invalid, void, or unconstitutional for any reason, such holding shall not render invalid, void, or unconstitutional any other section, subsection, sentence, provision, clause, or phrase of this Ordinance, and the same are deemed severable for this purpose.

<u>Section 6:</u> EMERGENCY. This Ordinance being designated to protect the health and safety of the inhabitants of the City of Muskogee, Oklahoma, an emergency is hereby declared to exist whereby the same shall be in full force and effect from and after its adoption and publication.

There are no changes from the item that was approved except for correcting the fund in which the budget amendment was taking place.

The increase in the General Fund is to eliminate significant financial liabilities of the city, unexpected and unappropriated expenditures, and unexpected and un-budgeted revenues.

The increase to the Animal Control License budget is to account for increased expenses and for donations received.

The increase to the Sales Tax Capital Outlay budget is to account for the grant received from the State of Oklahoma for a project at the Oklahoma Music Hall of Fame.

The increase to the 2019 Capital Improvements Fund Budget is to cover the City's portion of the Oklahoma Music Hall of Fame project.

WHEREAS, the City will increase the budget in the General Fund in the amount of \$2,375,367.37 to cover unanticipated and unappropriated expenditures;

WHEREAS, the City will increase the budget in the Animal Control License Fund in the amount of \$45,000.00 to cover unanticipated and unappropriated expenditures;

WHEREAS, the City will increase the budget in the Sales Tax Capital Outlay Fund in the amount of \$500,000.00 to cover unanticipated and unappropriated expenditures;

WHEREAS, the City will increase the budget in the 2019 Capital Improvements Budget in the amount of \$496,629.00 to cover unanticipated and unappropriated expenditures;

WHEREAS, Exhibits A, B, C, and D attached hereto are intended to be demonstrative of the action contemplated by this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MUSKOGEE, OKLAHOMA AS FOLLOWS:

SECTION 1 – INCREASE GENERAL FUND BUDGET: The City Council of the City of Muskogee does hereby authorize the increase of \$1,316,560.00 in expenditures in the General Fund budget by use of unencumbered and unexpended fund balances in accordance with Sec. 2-552 (B)(4) of the Muskogee City Code to eliminate a significant financial liability of the city, as evidenced by Exhibit A.

<u>SECTION 2 – INCREASE GENERAL FUND BUDGET</u>: The City Council of the City of Muskogee does hereby authorize the increase of \$90,000 in expenditures in the General Fund budget by use of unencumbered and unexpended fund balances in accordance with Sec. 2-552 (B)(2) of the Muskogee City Code for transfer to the Muskogee War Memorial Trust, as evidenced by **Exhibit A**.

<u>SECTION 3 – INCREASE GENERAL FUND BUDGET</u>: The City Council of the City of Muskogee does hereby authorize the increase of \$53,195 in expenditures in the General Fund budget by use of grant funds received from sources not anticipated in the budget to cover Historic Preservation expenditures, as evidenced by **Exhibit A**.

<u>SECTION 4 – INCREASE GENERAL FUND BUDGET</u>: The City Council of the City of Muskogee does hereby authorize the increase of \$495,612.37 in expenditures in the

General Fund budget by use of revenues from sale of land to cover expenses for sewer project in MMA, as evidenced by **Exhibit A**.

<u>SECTION 5 – INCREASE GENERAL FUND BUDGET</u>: The City Council of the City of Muskogee does hereby authorize the increase of \$420,000.00 in expenditures in the General Fund budget by use of revenues in excess of budget estimates unanticipated employee compensation costs, as evidenced by **Exhibit A**.

<u>SECTION 6 – INCREASE ANIMAL CONTROL LICENSE BUDGET</u>: The City Council of the City of Muskogee does hereby authorize the increase of \$45,000.00 in expenditures in the Animal Control License Fund budget by use of unexpended and unencumbered fund balances on hand at the end of the preceding fiscal year to cover unanticipated expenditures, as evidenced by **Exhibit B.**

<u>SECTION 7 – INCREASE SALES TAX CAPITAL OUTLAY BUDGET</u>: The City Council of the City of Muskogee does hereby authorize the increase of \$500,000.00 in expenditures in the Sales Tax Capital Outlay Fund budget by use of grant funds received from sources not anticipated in the budget to cover project expenditures, as evidenced by **Exhibit C.**

<u>SECTION 8 – INCREASE 2019 CAPITAL IMPROVEMENT BUDGET</u>: The City Council of the City of Muskogee does hereby authorize the increase of \$496,629.00 in expenditures in the 2019 Capital Improvement Fund budget by use of revenues in excess of budget estimates for a capital project at the Oklahoma Music Hall of Fame, as evidenced by **Exhibit D.**

RESOLUTION DECLARING THE INTENT TO CONSIDER APPROVAL OF A PROJECT PLAN AND CREATION OF ONE OR MORE TAX INCENTIVE DISTRICTS UNDER THE LOCAL DEVELOPMENT ACT; DIRECTING PREPARATION OF A PROJECT PLAN; APPOINTING A REVIEW COMMITTEE; DIRECTING THE REVIEW COMMITTEE TO MAKE FINDINGS AS TO ELIGIBILITY AND FINANCIAL IMPACT, IF ANY, ON AFFECTED TAXING JURISDICTIONS AND BUSINESS ACTIVITIES WITHIN THE DISTRICTS; DIRECTING THE REVIEW COMMITTEE TO MAKE A RECOMMENDATION WITH RESPECT TO THE PROPOSED PROJECT PLAN; DIRECTING THE PLANNING AND ZONING COMMISSION OF THE CITY OF MUSKOGEE TO DETERMINE CONFORMANCE OF THE PROPOSED PROJECT PLAN WITH THE MUSKOGEE COMPREHENSIVE PLAN AND TO MAKE A RECOMMENDATION WITH RESPECT TO THE PROPOSED PROJECT PLAN;

WHEREAS, it is an objective of the City of Muskogee ("City") to promote economic development within its boundaries in order to attract major investment, enhance the tax base, stimulate economic growth, and improve the quality of life in and around the City; and

WHEREAS, the City is considering stimulating private investment in a multi-phased development of one or more data center facilities ("Project") on approximately 418 acres of land within the John T. Griffin Industrial Park, generally located north of W. 53rd Street S, south of W. Smith Ferry Road, and east of S. 32nd Street W ("Project Area"); and

WHEREAS, in order to promote economic development, it is necessary and desirable to establish a legal framework and funding mechanism to provide public assistance to support the Project, and

WHEREAS, the Local Development Act, 62 O.S. § 850, et seq., was passed by the Oklahoma Legislature to implement Section 6C of Article X of the Oklahoma Constitution, which empowers the governing bodies of cities, towns, and counties to approve project plans and provide incentives, exemptions, and other forms of tax relief to further economic development efforts; and

WHEREAS, the economic viability of the Project likely depends upon the utilization of ad valorem property tax exemptions; and

WHEREAS, the City Council of the City, as the governing body of the City, is empowered to approve a project plan and create tax incentive districts to advance economic development in the City; and

WHEREAS, the Center for Economic Development Law has been engaged by the Muskogee City-County Port Authority to evaluate the eligibility and feasibility of the Project; and

WHEREAS, without the adoption of a project plan, the establishment of one or more incentive districts, and other authorizations provided for in the Local Development Act, much of the potential economic growth in the proposed Project Area would be difficult or impossible; and

WHEREAS, the Local Development Act provides for the appointment of a Review Committee to review and make a recommendation concerning the proposed district, plan, or project, to consider and make findings and recommendations with respect to the conditions establishing the eligibility of the proposed district, and to consider and determine whether the proposed plan and project will have a financial impact on any affected taxing jurisdiction within the proposed district and to report its findings and make its recommendations to the governing body; and

WHEREAS, the Local Development Act provides that the membership of the Review Committee shall consist of the following: a representative of the governing body who shall serve as chairperson; a representative of the planning commission having jurisdiction over the proposed district; a representative designated by each taxing jurisdiction within the proposed district whose taxes might be impacted by the plan; and three members representing the public at large as selected by the other committee members from a list of seven names submitted by the chairperson of the Review Committee; and

WHEREAS, consistent with the Local Development Act, the membership of the Review Committee shall consist of the following: one representative of the City of Muskogee, who shall serve as chairperson of the Review Committee; one representative of the Planning and Zoning Commission of the City of Muskogee, to be designated by that body; one representative of the Board of County Commissioners of Muskogee County, to be designated by that body; one representative of the Muskogee County Health Department, to be designated by that body; one representative of the Muskogee County Emergency Medical Service, to be designated by that body; one representative of the Eastern Oklahoma District Library System, to be designated by that body; one representative of the Indian Capital Technology Center District No. 4, to be designated by that body; one representative of the Hilldale Independent School District No. I-29 of Muskogee County, Oklahoma, to be designated by that body; one representative of the Muskogee Independent School District No. I-20, to be designated by that body; and three members representing the public at large, at least one of whom is a representative of the business community in the City selected by the other Review Committee members from a list of seven names submitted by the chairperson of the Review Committee; and

WHEREAS, the Review Committee shall review and make a recommendation concerning a proposed project plan including potential incentive districts, consider and make findings and recommendations with respect to the conditions establishing the eligibility of the proposed districts, and to consider and determine whether the proposed project plan will have a financial impact on any taxing jurisdiction and business activities within the proposed districts and to report its findings and make its recommendations to the City; and

WHEREAS, consistent with the Local Development Act, the Planning and Zoning Commission of the City of Muskogee shall review the proposed project plan, make its findings regarding conformance of the proposed project plan to the Muskogee Comprehensive Plan, and

shall make a recommendation on the proposed project plan to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Muskogee, Oklahoma:

- **Section 1**. The City Council of the City of Muskogee ("City Council") intends to consider approval of a project plan and the creation of one or more incentive districts to facilitate and support the viability of the Project and has directed the Center for Economic Development Law, as Special Counsel for Economic Development, to prepare a proposed project plan for consideration in accordance with the Local Development Act.
- **Section 2**. City staff and the Center for Economic Development Law are authorized and directed to assist in the process of consideration of a proposed project plan.
- Section 3. A Review Committee is hereby appointed whose membership shall consist of the following: one representative of the City, who shall serve as the chairperson of the Review Committee; one representative of the Planning and Zoning Commission of the City of Muskogee, to be designated by that body; one representative of the Board of County Commissioners of Muskogee County, to be designated by that body; one representative of the Muskogee County Emergency Medical Service, to be designated by that body; one representative of the Eastern Oklahoma District Library System, to be designated by that body; one representative of the Indian Capital Technology Center District No. 4, to be designated by that body; one representative of the Hilldale Independent School District No. I-29 of Muskogee County, Oklahoma, to be designated by that body; one representative of the Muskogee Independent School District No. I-20, to be designated by that body; and three members representing the public at large, at least one of whom is a representative of the business community in the City selected by the other Review Committee members from a list of seven names submitted by the chairperson of the Review Committee.
- **Section 4**. The City Council of the City of Muskogee shall appoint a member of the body to serve as the City's representative and chairperson of the Review Committee.
- **Section 5**. The chairperson of the Review Committee shall request that the Planning and Zoning Commission of the City of Muskogee, the Board of County Commissioners of Muskogee County, the Muskogee County Health Department, the Muskogee County Emergency Medical Service, the Eastern Oklahoma District Library System, the Indian Capital Technology Center District No. 4, the Hilldale Independent School District No. I-29 of Muskogee County, Oklahoma, and the Muskogee Independent School District No. I-20, each select a representative to serve on the Review Committee
- **Section 6**. The chairperson of the Review Committee shall submit a list of seven names of possible persons to represent the public at large on the Review Committee, at least one of whom is a representative of the business community in the City of Muskogee.
- **Section 7**. The other Review Committee members shall select three persons from the list submitted by the chairperson, who shall represent the public at large on the Review Committee;

at least one of the three people selected to represent the public at large shall be a representative of the business community in the City of Muskogee.

- **Section 8.** The Review Committee shall consider and make its findings and recommendations to the City Council with respect to the conditions establishing the eligibility of the proposed incentive districts and the appropriateness of approval of the proposed project plan and Project.
- **Section 9.** The Review Committee shall consider and determine whether the proposed project plan and Project will have a financial impact on any taxing jurisdiction within the proposed incentive districts and shall report its findings to the City Council.
- **Section 10.** The Planning and Zoning Commission of the City of Muskogee shall review the proposed project plan, make its findings regarding conformance of the proposed project plan to the Muskogee Comprehensive Plan, and shall make a recommendation on the proposed project plan to the City Council.
