I am submitting this report to Nueces County on activities by Family Counseling Service in performance of its obligation pursuant to Contract #20210304.

In July 2021, Family Counseling Service received funds in the amount of \$5,000 for the Nueces County fiscal year of 2020-2021. These funds were used to help pay for therapy to underinsured and uninsured residents of Nueces County.

The following information contains data of those Nueces County residents served from October 1, 2020 to September 30, 2021.

There were 738 Nueces County residents that received therapy services from Family Counseling Service. Of those, 68% addressed issues related to COVID-19.

The ethnicity of these clients is as follows:

- 66% Hispanic
- 21% Caucasian
- 3 % African American
- 5 % Other
- 5% Unknown

The marital status of the clients seen included:

- 59% Single
- 22% Married
- 19% Other/Unknown
